#### COMMENTARY

Global markets declined in May due to uncertainty regarding economic stability in Europe. An underweight position in the Fund to European stocks and the euro has had a positive contribution to relative performance for the year. Nevertheless, stock selections in the US and China have hurt Fund performance for the year-to-date. Orbis believes that the recent downturn in the market will allow them to add to existing positions and may create several new opportunities. They remain focused on identifying and selecting high quality companies which are trading at a discount to their perceived fair value and are temporarily out of favour.


