COMMENTARY

Although the Orbis Global Equity Fund slightly underperformed the FTSE World Index in July, for the year to date the Fund has outperformed the FTSE World Index by just over 10%. This outperformance has come from stock selection, specifically the overweight exposure to Asian shares, and companies in the Technology sector.

Although the Optimal SA Funds have lagged the very strong stock markets, their returns have been higher than cash or bonds. Interest rates offshore are extremely low, and the performance of the Optimal SA Funds will therefore be driven not by positive cash return from the hedging, but rather by the ability of Orbis' shares to outperform the market.

In terms of currency exposure, the Fund remains overweight the yen relative to the benchmark, as well as overweight Asia ex-Japan currencies. The Fund is underweight the dollar and the euro.

The return for the 12 months to the end of July was 7.1% in US dollars versus the benchmark's -9.4%.

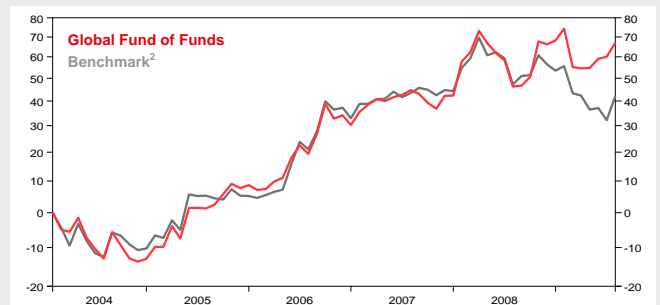
¹A Total Expense Ratio (TER) is a measure of a portfolio's assets that are relinquished as operating expenses. The total operating expenses are expressed as a percentage of the average value of the portfolio, calculated for the year to the end of June 2009. Included in the TER is the proportion of costs that are incurred by the performance component, fee at benchmark, trading costs (including brokerage, VAT, STT, STRATE and insider trading levy) and other expenses. These are disclosed separately as percentages of the net asset value. A higher TER ratio does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TERs. The information provided is applicable to class A units.
