Fund description

The Fund invests in a mix of absolute return funds managed by Allan Gray's offshore investment partner, Orbis Investment Management Limited. The typical net equity exposure of the Fund is between 0% and 20%. The Orbis Optimal SA funds included in the Fund use exchange-traded derivative contracts on stock market indices to reduce net equity exposure. In these funds, the market exposure of equity portfolios is effectively replaced with cash-like exposure, plus or minus Orbis' skills in delivering returns above or below the market. Returns are likely to be less volatile than those of a foreign equity or balanced fund. Although the Fund is fully invested outside South Africa, the units in the Fund are priced and traded daily in rands. When considered in rands, returns of this foreign fund are likely to be more volatile than domestic funds with similar equity constraints.

Fund objective and benchmark

The Fund aims to provide a high degree of capital stability (when measured in the foreign currency denominations of the underlying Orbis Funds), while producing long-term returns that are superior to foreign currency bank deposits. The Fund's benchmark is the simple average of the benchmarks of the underlying Orbis funds.

How we aim to achieve the Fund's objective

The Fund invests only in the Optimal SA absolute return funds managed by our offshore investment partner, Orbis Investment Management Limited. Within the Optimal funds, Orbis uses in-house research to identify companies around the world whose shares can be purchased for less than Orbis' assessment of their long-term intrinsic value. This long-term perspective enables them to buy shares which are shunned by the stock market because of their unexciting or poor short-term prospects, but which are relatively attractively priced if one looks to the long term. This is the same approach as that used by Allan Gray to invest in South African equities, except that Orbis is able to choose from many more shares, listed internationally.

The Orbis Optimal SA funds reduce most of their stock market risk by the use of exchange-traded derivative futures contracts. The Orbis Optimal SA funds will typically retain a small portion of their exposure to equity markets, but the level of exposure may be varied depending on Orbis' assessment of the potential returns on global stock markets relative to their risk of capital loss. The underlying funds' returns are therefore derived partly from their relatively low exposure to stock markets, partly from Orbis' selected share returns relative to those markets, and partly from foreign currency cash-equivalent returns. The Fund's currency exposure is actively managed both within the underlying Orbis funds and through our selection of Orbis funds.

Suitable for those investors who

- Seek steady absolute returns ahead of those of cash measured in global currencies
- Wish to invest in international assets without having to personally expatriate rands
- Are comfortable with taking on the risk of currency fluctuation, but prefer little exposure to stock market risk
- Wish to use the Fund as a foreign absolute return 'building block' in a diversified multi-asset class portfolio

Total expense ratio (TER)

The TER for the year ending 30 September 2012 is 1.22% and included in this is a performance fee of 0.0% and trading costs of 0.17%. The annual management fee rate charged by Orbis in the underlying funds for the three months ending 31 October 2012 was 0.98% (annualised). These figures are inclusive of VAT, where applicable. Fund returns are quoted after deduction of costs incurred within the Fund so the TER should not be deducted from Fund returns (refer to page 2 for further information).

Fund manager quarterly commentary as at 30 September 2012

As a contrarian investor, Orbis is always trying to find companies whose likely future will be much better than their perceived future. Orbis does this by comparing its assessment of the company's long-term, fundamental value with its share price. The greatest opportunities tend to arise when there is a wide discrepancy between the two. This point is particularly relevant for the Orbis Optimal SA Fund. By hedging most of its stock market exposure, the Fund also ends up taking a short position in all of the sectors and stocks that the Fund does not own. As a result the Fund's return is driven primarily by the relative performance of the equities it holds.

The US healthcare sector provides an illustration. The Optimal SA Fund has very little exposure to the pharmaceutical sector, but favours health insurers, mainly WellPoint, Aetna, and Humana. To put this in perspective, pharmaceutical stocks account for 6% of the S&P 500, while health insurers have a mere 1% weighting.

The health insurers that your Fund owns have several appealing characteristics. They offer attractive long-term earnings and cash flow growth, are deeply out of favour with investors, and trade at depressed valuations due to fears and concerns which Orbis regards as short term. At today's valuations, the market essentially assumes a near collapse of these companies' cash flows, a perceived future that Orbis believes is far too bleak.

Orbis' view is that the future for these companies will likely be much better than the stock market's current perception. Valuations on health insurance shares are not far from where they were during the darkest days of the US healthcare reform debate, despite considerably greater clarity on what the new legislation will mean for the industry. On average, these companies generate free cash flow per share equivalent to 13% of their current share prices. Said another way, it would take less than eight years for them to generate enough cash to cover the cost of buying these companies today – and shareholders would still own the businesses outright.

In contrast, the pharmaceutical sector is now trading close to its highest valuation level in about five years and is currently in favour with investors seeking stable, mid-single digit dividend yields. As with the health insurers, Orbis expects the likely future for these shares to also be different from their recent past. For many large pharmaceutical companies, patents on key drugs have or will soon expire, while those in the pipeline appear to offer little growth potential. While pharmaceuticals may seem to be a 'safer' place to hide at the moment, Orbis' view is that clients will be more richly rewarded in the long run by investing in high quality health insurers, which are currently trading at attractive valuations relative to their peers and their history. The Orbis Optimal SA Fund is positioned accordingly.

Unit price

Unit trust prices are calculated on a net asset value basis, which is the total market value of all assets in the portfolio including any income accruals and less any permissible deductions from the portfolio divided by the number of units in issue. Forward pricing is used and Fund valuations take place at approximately 16:00 each business day. Purchase and redemption requests must be received by the manager by 14:00 each business day to receive that day's price. Fluctuations and movements in exchange rates may also cause the value of underlying international investments to go up or down.

Fees

A schedule of fees, charges and maximum commissions is available on request from the manager. Commission and incentives may be paid and if so, would be included in the overall costs.

TER

*TERs are shown for class A units only

The Total Expense Ratio (TER) is the percentage of the fund's average assets under management that has been used to pay the fund's operating expenses over the past year. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged), trading costs (including brokerage, STT, STRATE and insider trading levy), VAT and other expenses. Since unit trust expenses vary, the current TER cannot be used as an indication of future TERs. All Allan Gray performance figures are quoted after the deduction of costs incurred within the Fund so the TER is not a new cost. A higher TER ratio does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. TERs should then be used to evaluate whether the Fund performance offers value for money.

Performance

Collective Investment Schemes in Securities (unit trusts) are generally medium- to long-term investments. The value of units may go down as well as up and past performance is not necessarily a guide to the future. Performance figures are from Allan Gray Proprietary Limited and are for lump sum investments with income distributions reinvested.
