Fund description and summary of investment policy

The Fund invests in a mix of absolute return funds managed by Allan Gray's offshore investment partner, Orbis Investment Management Limited. The typical net equity exposure of the Fund is between 0% and 20%. The Orbis Optimal SA funds included in the Fund use exchange-traded derivative contracts on stock market indices to reduce net equity exposure. In these funds, the market exposure of equity portfolios is effectively replaced with cash-like exposure, plus or minus Orbis' skills in delivering returns above or below the market. Returns are likely to be less volatile than those of a foreign equity or balanced fund. Although the Fund is fully invested outside South Africa, the units in the Fund are priced and traded daily in rands. When considered in rands, returns of this foreign fund are likely to be more volatile than domestic funds with similar equity constraints.

Fund objective and benchmark

The Fund aims to provide a high degree of capital stability (when measured in the foreign currency denominations of the underlying Orbis Funds), while producing long-term returns that are superior to foreign currency bank deposits. The Fund's benchmark is the simple average of the benchmarks of the underlying Orbis funds.

How we aim to achieve the Fund's objective

The Fund invests only in the Optimal SA absolute return funds managed by our offshore investment partner, Orbis Investment Management Limited. Within the Optimal funds, Orbis uses in-house research to identify companies around the world whose shares can be purchased for less than Orbis' assessment of their long-term intrinsic value. This long-term perspective enables them to buy shares which are shunned by the stock market because of their unexciting or poor short-term prospects, but which are relatively attractively priced if one looks to the long term. This is the same approach as that used by Allan Gray to invest in South African equities, except that Orbis is able to choose from many more shares, listed internationally.

The Orbis Optimal SA funds reduce most of their stock market risk by the use of exchange-traded derivative futures contracts. The Orbis Optimal SA funds will typically retain a small portion of their exposure to equity markets, but the level of exposure may be varied depending on Orbis' assessment of the potential returns on global stock markets relative to their risk of capital loss. The underlying funds' returns are therefore derived partly from their relatively low exposure to stock markets, partly from Orbis' selected share returns relative to those markets, and partly from foreign currency cashequivalent returns. The Fund's currency exposure is actively managed both within the underlying Orbis funds and through our selection of Orbis funds.

Suitable for those investors who

- Seek steady absolute returns ahead of those of cash measured in global currencies
- Wish to invest in international assets without having to personally expatriate rands
- Are comfortable with taking on the risk of currency fluctuation, but prefer little exposure to stock market risk
- Wish to use the Fund as a foreign absolute return 'building block' in a diversified multi-asset class portfolio

Annual management fee and total expense ratio (TER)

Allan Gray does not charge an annual management fee but is paid a marketing and distribution fee by Orbis.



Fund manager quarterly commentary as at 31 March 2015

The Orbis Optimal SA Funds are designed to capture the value of Orbis' bottom-up stock picking. Indeed, it is the performance of Orbis' stock selections relative to its local markets that has made the largest positive contribution to the returns since the Funds' inception. However, stockpicking results over shorter periods can be highly volatile and, over the past year, Orbis' selections in several regions have hurt performance.

While times like these can be painful, Orbis remains resolute in its commitment to the investment philosophy that has served it well over its 25-year history. At Orbis and Allan Gray, we aim to buy shares trading at a discount to our assessment of intrinsic value, rather than to buy fairly valued shares in the expectation that they will become expensive. We believe that chasing performance is one of the worst things we can do on your behalf. As the valuation dispersion widens between the shares Orbis finds attractive and the momentum-driven shares that are not owned, Orbis has become increasingly optimistic about the potential for relative returns.

Taking Europe as an example, Orbis has had limited exposure to the major index components and shares that have performed well recently, like Volkswagen, which has risen about 25% in months from mid-January, when rumours of eurozone quantitative easing were confirmed. At the same time, many of Orbis' favoured small- and mid-cap shares have underperformed.

In some ways, the situation in Europe today is a less extreme parallel of the stock-picking environment of the late 1990s. Back then, the Orbis Funds were invested in several solid but unglamorous European businesses, including a bus company, a brewer and a grocery store chain, but owned few of the large-cap technology shares that dominated market indices. Once again, Orbis owns shares of 'good', but unspectacular, businesses that have struggled to keep up with a market driven upwards by speculative liquidity. Orbis believes that these shares trade at steep discounts to intrinsic value, and some have become even cheaper.

A good example is Thomas Cook, the UK-listed travel agency. Having suffered a near-terminal cash flow crisis in 2012, the company's fortunes have been turned around by a strong management team. Improving consumer sentiment in the company's major markets could also serve as a tailwind. However, in the 12 months to February, the stock underperformed the UK index by approximately 35%. At 15 times 2015 earnings, the stock does not look obviously cheap, until one remembers that Thomas Cook's profit margins are currently depressed, but on a strong path of recovery.

Orbis remains focused on investing your capital in companies that stand to gain meaningfully from events turning out better than markets expect, while minimising exposure to those that could permanently impair shareholder capital in difficult times. While the market can remain irrational for prolonged periods, we believe that by adhering to this philosophy we can build a portfolio of shares that will deliver superior relative returns over the long term.

The Management Company has been approved by the regulatory authority of Botswana to market its unit trusts in Botswana, however it is not supervised or licensed in Botswana. Allan Gray Proprietary Limited (the 'Investment Manager'), an authorised financial services provider, is the appointed investment manager of the Management Company. Purchase and redemption requests must be received by the Management Company by 14:00 each business day to receive that day's price. Unit trust prices are available daily on www.allangray.co.za

Permissible deductions may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and trustee fees. A schedule of fees, charges and maximum commissions is available on request from Allan Gray.

Total expense ratio (TER)

Total expense ratio (TER) The TER is the percentage of the Fund's average assets under management that has been used to pay the Fund's operating expenses over the past year. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged), trading costs (including brokerage, STT, STRATE and FSB Investor Protection Levy), VAT and other expenses. Since unit trust expenses vary, the current TER cannot be used as an indication of future TERs. The Fund's performance figures are quoted after the deduction of costs incurred within the Fund so the TER is not a new cost. A higher TER ratio does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. TERs should then be used to evaluate whether the Fund performance offers value for money.

A fund of funds is a unit trust that invests in other unit trusts, which charge their own fees. Allan Gray does not charge any additional fees in its funds of funds.
