

ALLAN GRAY-ORBIS GLOBAL OPTIMAL FUND OF FUNDS

Fund managers: Duncan Artus. (The underlying Orbis funds are managed by Orbis.) **Inception date:** 2 March 2010

Fund description and summary of investment policy

The Fund invests in a mix of absolute return funds managed by Allan Gray's offshore investment partner, Orbis Investment Management Limited. The typical net equity exposure of the Fund is between 0% and 20%. The Orbis Optimal SA funds included in the Fund use exchange-traded derivative contracts on stock market indices to reduce net equity exposure. In these funds, the market exposure of equity portfolios is effectively replaced with cash-like exposure, plus or minus Orbis' skills in delivering returns above or below the market. Returns are likely to be less volatile than those of a foreign equity or balanced fund. Although the Fund is fully invested outside South Africa, the units in the Fund are priced and traded daily in rands. When considered in rands, returns of this foreign fund are likely to be more volatile than domestic funds with similar equity constraints.

Fund objective and benchmark

The Fund aims to provide a high degree of capital stability (when measured in the foreign currency denominations of the underlying Orbis Funds), while producing long-term returns that are superior to foreign currency bank deposits. The Fund's benchmark is the simple average of the benchmarks of the underlying Orbis funds.

How we aim to achieve the Fund's objective

The Fund invests only in the Optimal SA absolute return funds managed by our offshore investment partner, Orbis Investment Management Limited. Within the Optimal funds, Orbis uses in-house research to identify companies around the world whose shares can be purchased for less than Orbis' assessment of their long-term intrinsic value. This long-term perspective enables them to buy shares which are shunned by the stock market because of their unexciting or poor short-term prospects, but which are relatively attractively priced if one looks to the long term. This is the same approach as that used by Allan Gray to invest in South African equities, except that Orbis is able to choose from many more shares, listed internationally.

The Orbis Optimal SA funds reduce most of their stock market risk by the use of exchange-traded derivative futures contracts. The Orbis Optimal SA funds will typically retain a small portion of their exposure to equity markets, but the level of exposure may be varied depending on Orbis' assessment of the potential returns on global stock markets relative to their risk of capital loss. The underlying funds' returns are therefore derived partly from their relatively low exposure to stock markets, partly from Orbis' selected share returns relative to those markets, and partly from foreign currency cash-equivalent returns. The Fund's currency exposure is actively managed both within the underlying Orbis funds and through our selection of Orbis funds.

Suitable for those investors who

- Seek steady absolute returns ahead of those of cash measured in global currencies
- Wish to invest in international assets without having to personally expatriate rands
- Are comfortable with taking on the risk of currency fluctuation, but prefer little exposure to stock market risk
- Wish to use the Fund as a foreign absolute return 'building block' in a diversified multi-asset class portfolio

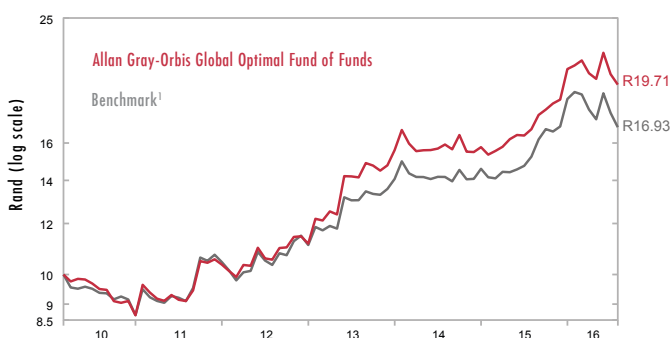

Meeting the Fund objective

Since inception and over the latest five-year period, the Fund has outperformed its benchmark, although it should be noted that the returns on dollar and euro cash have been low over this period. There has been some volatility in the Fund's returns. The underlying funds' maximum drawdowns to date, in their reporting currencies, are 10% for the Orbis Optimal SA Dollar class and 7% for the Orbis Optimal SA Euro class.

Annual management fee

Allan Gray does not charge an annual management fee but is paid a marketing and distribution fee by Orbis.

Orbis charges annual management fees within the underlying Orbis funds. Each fund's fee rate is calculated based on the fund's performance relative to its own benchmark. For more information please refer to the respective Orbis Funds' factsheets, which can be found at www.allangray.co.za

Total expense ratio (TER) and Transaction costs

The annual management fees charged by Orbis are included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a 3-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

Fund manager quarterly commentary as at 30 June 2016

As noted in previous commentaries, the performance of the Orbis Optimal funds depends in large part on individual stock selections. This has arguably been more challenging than usual in recent years as many stock markets in the developed world have exhibited strong trending behaviour – i.e. winners continuing to win – and are trading at fairly rich valuations. But there are always mispriced shares to be found, particularly those of businesses that are undergoing wide-ranging change.

In our experience, compelling opportunities can often arise when a company has experienced some sort of crisis or failure. A good management team can return the business to health, drive a meaningful reappraisal of its prospects from the stock market, and deliver pleasing returns for shareholders. But even in successful turnarounds, progress is rarely smooth and it is not unusual to see major, unanticipated challenges. It takes a great deal of patience and resilience to take full advantage of these situations.

Thomas Cook Group, a European travel agency and an investment in the Orbis Optimal SA Fund, is one such example. Over the last two years, geopolitical and terrorist events have dramatically reduced demand for tourism in Northern Africa, Egypt and Turkey – all of which were formerly popular destinations for Thomas Cook customers. At relatively short notice, the company has had to re-route huge numbers of travellers to alternative destinations in the Western Mediterranean and further afield, which means lining up new hotels, finding local support for tourists, and securing landing slots for its aircraft. This is not cheap, and the company recently announced that there would be a modest negative impact on current year profits from these activities.

Adding to near-term difficulties will be the fall-out from the recent Brexit decision. While lower consumer confidence across Europe is unwelcome for the business, Orbis does not believe the impact is likely to be unmanageable or sustaining. Investors have taken a far more pessimistic view of these developments, and Thomas Cook shares are down more than 50% in the last year.

Orbis believes this reaction is too extreme and short-sighted. While these disruptions to the business are unwelcome, they also reveal useful insights about the company and its management team. It is encouraging that Thomas Cook can now absorb this kind of external shock with a fairly minimal impact on profitability. Where others see short-term disappointment, Orbis sees evidence of operational improvements made under the current management team that have not only increased margins, but also increased the resilience of the business. Said another way, Orbis believes the market is losing faith in Thomas Cook for reasons that are not only beyond the company's control, but also unlikely to persist with similar frequency in the future.

In situations like these, a short-term disruption can be a blessing in disguise. As painful as it may be for the company's near-term profitability, Orbis believes it has provided a unique opportunity to build an investment position at a larger discount to intrinsic value and with higher conviction that the business is improving and likely to continue its turnaround in future years.

Orbis typically retains modest long exposure to the stock markets it considers to be the most attractive based on its bottom-up research and, likewise, uses hedging to eliminate exposure to those stock markets where it believes assets are overvalued. A slight change was that the Fund eliminated its previous negative net beta-adjusted exposure to the Japanese stock market, and instead retained a neutral stock market exposure, as we no longer believe the Japanese stock market is broadly overvalued. The Fund continues to retain a meaningful net long exposure to selected Asian stock markets, which Orbis believes are broadly undervalued. There have been no material changes to the portfolio's currency exposures or to its key individual positions, with the top-10 holdings largely unchanged.

Management Company

Allan Gray Unit Trust Management (RF) Proprietary Limited (the 'Management Company') is registered as a management company under the Collective Investment Schemes Control Act 45 of 2002, in terms of which it operates 11 unit trust portfolios under the Allan Gray Unit Trust Scheme, and is supervised by the Financial Services Board ('FSB'). The Management Company is incorporated under the laws of South Africa and has been approved by the regulatory authority of Botswana to market its unit trusts in Botswana, however it is not supervised or licensed in Botswana. Allan Gray Proprietary Limited (the 'Investment Manager'), an authorised financial services provider, is the appointed Investment Manager of the Management Company and is a member of the Association for Savings & Investment South Africa (ASISA). The trustee/custodian of the Allan Gray Unit Trust Scheme is Rand Merchant Bank, a division of FirstRand Bank Limited. Performance

Collective Investment Schemes in Securities (unit trusts or funds) are generally medium- to long-term investments. Fund mandate

The Fund may be closed to new investments at any time in order to be managed according to its mandate. Unit trusts are traded at ruling prices and can engage in borrowing and scrip lending. The Fund may borrow up to 10% of its market value to bridge insufficient liquidity.

Unit price

Unit trust prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund including any income accruals and less any permissible deductions from the Fund divided by the number of units in issue. Forward pricing is used and fund valuations take place at approximately 16:00 each business day. Purchase and redemption requests must be received by the Management Company by 14:00 each business day to receive that day's price. Unit trust prices are available daily on www.allangray.co.za

Fees

Permissible deductions may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and trustee fees. A schedule of fees, charges and maximum commissions is available on request from Allan Gray.

Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past three years. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged), VAT and other expenses like audit and trustee fees. Transaction costs (including brokerage, Securities Transfer Tax [STT], STRATE and FSB Investor Protection Levy and VAT thereon) are shown separately. Transaction costs are a necessary cost in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of financial product, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. As unit trust expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER ratio does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and Transaction costs is shown as the Total investment charge.

Fund of funds

A fund of funds is a unit trust that invests in other unit trusts, which charge their own fees. Allan Gray does not charge any additional fees in its funds of funds.

Foreign exposure

The Fund invests in foreign funds managed by Orbis Investment Management Limited, our offshore investment partner.
