

**Fund description and summary of investment policy**

The Fund invests in a mix of absolute return funds managed by Allan Gray's offshore investment partner, Orbis Investment Management Limited. The typical net equity exposure of the Fund is between 0% and 20%. The Orbis Optimal SA funds included in the Fund use exchange-traded derivative contracts on stock market indices to reduce net equity exposure. In these funds, the market exposure of equity portfolios is effectively replaced with cash-like exposure, plus or minus Orbis' skills in delivering returns above or below the market. Returns are likely to be less volatile than those of a foreign equity or balanced fund. Although the Fund's investment universe is global, the units in the Fund are priced and traded daily in rands. When considered in rands, returns of this foreign fund are likely to be more volatile than domestic funds with similar equity constraints.

**Fund objective and benchmark**

The Fund aims to provide a high degree of capital stability (when measured in the foreign currency denominations of the underlying Orbis Funds), while producing long-term returns that are superior to foreign currency bank deposits. The Fund's benchmark is the simple average of the benchmarks of the underlying Orbis funds.

**How we aim to achieve the Fund's objective**

The Fund invests only in the Optimal SA absolute return funds managed by our offshore investment partner, Orbis Investment Management Limited. Within the Optimal funds, Orbis uses in-house research to identify companies around the world whose shares can be purchased for less than Orbis' assessment of their long-term intrinsic value. This long-term perspective enables them to buy shares which are shunned by the stock market because of their unexciting or poor short-term prospects, but which are relatively attractively priced if one looks to the long term. This is the same approach as that used by Allan Gray to invest in South African equities, except that Orbis is able to choose from many more shares, listed internationally. The Orbis Optimal SA funds reduce most of their stock market risk by the use of exchange-traded derivative futures contracts. The Orbis Optimal SA funds will typically retain a small portion of their exposure to equity markets, but the level of exposure may be varied depending on Orbis' assessment of the potential returns on global stock markets relative to their risk of capital loss. The underlying funds' returns are therefore derived partly from their relatively low exposure to stock markets, partly from Orbis' selected share returns relative to those markets, and partly from foreign currency cash-equivalent returns. The Fund's currency exposure is actively managed both within the underlying Orbis funds and through our selection of Orbis funds.

**Suitable for those investors who**

- Seek steady absolute returns ahead of those of cash measured in global currencies
- Wish to invest in international assets without having to personally expatriate rands
- Are comfortable with taking on the risk of currency fluctuation, but prefer little exposure to stock market risk
- Wish to use the Fund as a foreign absolute return 'building block' in a diversified multi-asset class portfolio

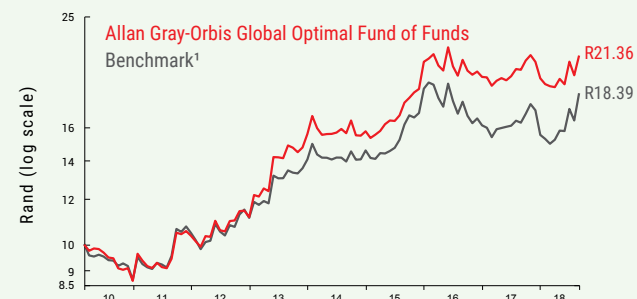

### Meeting the Fund objective

Since inception and over the latest five-year period, the Fund has outperformed its benchmark, although it should be noted that the returns on dollar and euro cash have been low over this period. There has been some volatility in the Fund's returns. The underlying funds' maximum drawdowns to date, in their reporting currencies, are 10% for the Orbis Optimal SA Dollar class and 7% for the Orbis Optimal SA Euro class.

### Annual management fee

Allan Gray does not charge an annual management fee but is paid a marketing and distribution fee by Orbis.

Orbis charges annual management fees within the underlying Orbis funds. Each fund's fee rate is calculated based on the fund's performance relative to its own benchmark. ### Total expense ratio (TER) and Transaction costs

The annual management fees charged by Orbis are included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

Over the last 28 years, the Orbis Global Equity Strategy has returned roughly 14% per annum before fees in US dollars, and the Orbis Optimal Strategy has returned approximately 10% per annum before fees. We like to think about these long-term returns as combinations of three components – a risk-free rate, an equity risk premium, and the Orbis value add.

The risk-free rate is the return on cash. In US dollar terms, this has averaged 3% per annum since 1990. The equity risk premium is the additional return you would expect as compensation for taking on risk by providing capital to companies. This has averaged 4% per annum since 1990. The final piece – the value added by Orbis – is any extra return that we are able to generate. This has averaged 7% per annum since 1990, which gets you to Global Equity's 14% per annum long-term gross return.

Simply put, Optimal is designed to capture the risk-free rate and the value added by Orbis without the equity risk premium. The Optimal Strategy has therefore given up roughly 4% per annum versus the Orbis Global Equity Strategy since its inception.

However, over the last 5 years the Orbis Optimal SA (US\$) Fund returned 3.8% per annum before fees, which is a 6.2% per annum below the longer-term level.

### The last five years

Why has this been the case? Firstly, the risk-free rate has been squeezed down to historically low levels. Instead of the 3% that we saw from 1990, we have experienced closer to 0.5% over the last half decade. Secondly, the value added by Orbis within the Orbis Optimal SA (US\$) Fund has delivered only 3.3% per annum over the last five years, less than half of the longer-term average.

Perhaps most pertinent is the equity risk premium. Over the last five years, the equity risk premium delivered around 9% per annum – more than double the norm – with record low volatility. This has been one of the worst periods in history to have hedged out exposure to equities.

### The next five years

In our view, the headwinds that the Optimal SA funds have faced in recent years are more cyclical than structural.

For a start, the risk-free rate is currently around 2% in the US, which is closer to the long-run average. We have no edge in predicting where interest rates will

head over the next half decade, but we do know that the levels experienced in recent times are extremely low in the context of history.

The most significant driver of the Optimal SA funds' returns is the value we add through stock selection. Our ability to create value for clients is dictated by two things – the availability of mispriced securities, and our ability to exploit those inefficiencies. Only the latter is under our control, and we continue to apply our time-tested approach and investment philosophy.

### The raw materials for alpha

The availability of mispriced securities is not under our control. While the environment has been tough of late, we don't believe this will last. In our view, inefficiencies have become more prevalent since the financial crisis. One possible reason is the spillover effect from central bank manipulation, and another is the rise of passive investing. As more money flows to indiscriminate baskets of stocks, less goes to investors who set market prices through their active decisions.

Meaningful mispricings are ultimately a blessing for investors like Orbis, who look to profit from undervalued stocks. But while the above trends persist, they slow the process by which stock prices move to reflect companies' intrinsic values. So while the environment may be rich with relative value opportunities, significant extra patience is required to take advantage of them.

Finally, it's worth cycling back to the component of return that is actively avoided within the Optimal SA funds – the equity risk premium. It has had an extraordinary run, but there is no such thing as a free lunch in investing. Going forward it seems unlikely that the funds' stock market hedging will prove to be as costly as it was over the last cycle.

The Fund increased its exposure to selected equities in North America and Japan over the quarter, along with its level of hedging in North America. Balanced with slightly lower exposure to selected stocks in Europe and Asia ex-Japan, this left the Fund's overall beta-adjusted stock market exposure largely unchanged. Among individual positions, the largest addition was to oil and gas services business Schlumberger, which is now a top holding.

### Management Company

Allan Gray Unit Trust Management (RF) Proprietary Limited (the 'Management Company') is registered as a management company under the Collective Investment Schemes Control Act 45 of 2002, in terms of which it operates 11 unit trust portfolios under the Allan Gray Unit Trust Scheme, and is supervised by the Financial Sector Conduct Authority ('FSCA'). The Management Company is incorporated under the laws of South Africa and has been approved by the regulatory authority of Botswana to market its unit trusts in Botswana, however it is not supervised or licensed in Botswana. Allan Gray Proprietary Limited (the 'Investment Manager'), an authorised financial services provider, is the appointed Investment Manager of the Management Company and is a member of the Association for Savings & Investment South Africa (ASISA). The trustee/custodian of the Allan Gray Unit Trust Scheme is Rand Merchant Bank, a division of FirstRand Bank Limited. ### Performance

### Fund mandate

The Fund may be closed to new investments at any time in order to be managed according to its mandate. Unit trusts are traded at ruling prices and can engage in borrowing and scrip lending. The Fund may borrow up to 10% of its market value to bridge insufficient liquidity.

### Unit price

Unit trust prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund including any income accruals and less any permissible deductions from the Fund divided by the number of units in issue. Forward pricing is used and fund valuations take place at approximately 16:00 each business day.

Purchase and redemption requests must be received by the Management Company by 14:00 each business day to receive that day's price. Unit trust prices are available daily on [www.allangray.co.za](http://www.allangray.co.za)

### Fees

Permissible deductions may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and trustee fees. A schedule of fees, charges and maximum commissions is available on request from Allan Gray.

### Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged), VAT and other expenses like audit and trustee fees. Transaction costs (including brokerage, Securities Transfer Tax [STT], STRATE and FSCA Investor Protection Levy and VAT thereon) are shown separately. Transaction costs are a necessary cost in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of financial product, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. As unit trust expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER ratio does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and Transaction costs is shown as the Total investment charge.

### Fund of funds

A fund of funds is a unit trust that invests in other unit trusts, which charge their own fees. Allan Gray does not charge any additional fees in its funds of funds.

### Foreign exposure

The Fund invests in foreign funds managed by Orbis Investment Management Limited, our offshore investment partner.
