Fund description and summary of investment policy

The Fund invests in a mix of absolute return funds managed by Allan Gray's offshore investment partner, Orbis Investment Management Limited. The typical net equity exposure of the Fund is between 0% and 20%. The Orbis Optimal SA funds included in the Fund use exchange-traded derivative contracts on stock market indices to reduce net equity exposure. In these funds, the market exposure of equity portfolios is effectively replaced with cash-like exposure, plus or minus Orbis' skills in delivering returns above or below the market. Returns are likely to be less volatile than those of a foreign equity or balanced fund. Although the Fund's investment universe is global, the units in the Fund are priced and traded daily in rands. When considered in rands, returns of this foreign fund are likely to be more volatile than domestic funds with similar equity constraints.

Fund objective and benchmark

The Fund aims to provide a high degree of capital stability (when measured in the foreign currency denominations of the underlying Orbis Funds), while producing long-term returns that are superior to foreign currency bank deposits. The Fund's benchmark is the simple average of the benchmarks of the underlying Orbis funds.

How we aim to achieve the Fund's objective

The Fund invests only in the Optimal SA absolute return funds managed by our offshore investment partner, Orbis Investment Management Limited. Within the Optimal funds, Orbis uses in-house research to identify companies around the world whose shares can be purchased for less than Orbis' assessment of their long-term intrinsic value. This long-term perspective enables them to buy shares which are shunned by the stock market because of their unexciting or poor short-term prospects, but which are relatively attractively priced if one looks to the long term. This is the same approach as that used by Allan Gray to invest in South African equities, except that Orbis is able to choose from many more shares, listed internationally. The Orbis Optimal SA funds reduce most of their stock market risk by the use of exchange-traded derivative futures contracts. The Orbis Optimal SA funds will typically retain a small portion of their exposure to equity markets, but the level of exposure may be varied depending on Orbis' assessment of the potential returns on global stock markets relative to their risk of capital loss. The underlying funds' returns are therefore derived partly from their relatively low exposure to stock markets, partly from Orbis' selected share returns relative to those markets, and partly from foreign currency cash-equivalent returns. The Fund's currency exposure is actively managed both within the underlying Orbis funds and through our selection of Orbis funds.

Suitable for those investors who

- Seek steady absolute returns ahead of those of cash measured in global currencies
- Wish to invest in international assets without having to personally expatriate rands
- Are comfortable with taking on the risk of currency fluctuation, but prefer little exposure to stock market risk
- Wish to use the Fund as a foreign absolute return 'building block' in a diversified multi-asset class portfolio

Meeting the Fund objective

Since inception, the Fund has outperformed its benchmark, although it should be noted that the returns on dollar and euro cash have been low over this period. Over the latest five-year period, the Fund has underperformed its benchmark. There has been some volatility in the Fund's returns. The underlying funds' maximum drawdowns to date, in their reporting currencies, are 16% for the Orbis Optimal SA Dollar class and 19% for the Orbis Optimal SA Euro class.

Allan Gray does not charge an annual management fee but is paid a marketing and distribution fee by Orbis.

Total expense ratio (TER) and Transaction costs

The annual management fees charged by Orbis are included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

Allan Gray-Orbis Global Optimal Fund of Funds

Since March of 2009, the MSCI World Index has delivered a remarkable 13% per annum return – well above any reasonable long-term expectation for equities and ranking amongst the strongest bull markets of all time. This period of excess return perhaps isn't too surprising given the cheap starting point and incredible efforts by central banks to keep a lid on the yields of "risk-free" assets.

But headline returns don't tell the whole story. A repeated pattern we have observed historically is that extreme headline market returns, whether positive or negative, often coincide with extreme stock-level mispricings. The Japan bubble in the late 1980s and the tech bubble in the late 1990s drove the market higher, but the underlying dispersion between the cheapest and most expensive shares grew in a similar manner.

Once the prevailing trends eventually broke, headline returns were lacklustre but opportunities for excess relative returns were pronounced. These were healthy periods for alpha generation in the Orbis Equity Strategies and for Optimal as a result. We can't predict what the future holds, but Optimal is designed to help protect capital when these extreme moments inevitably arrive.

Today's market looks similar to those past periods in our view. As value-oriented stock pickers, we tend to struggle most when overpriced investments continue to rise and underpriced investments continue to fall. We would argue that this type of environment has been in place more often than not over the last decade.

As painful as periods like this may be, they can also be the source of longer-term opportunity. Indeed, while stock markets as a whole look richly priced, we are starting to see great absolute value embedded in many of our holdings.

A good example is Honda Motor. At current prices, Honda's valuation is trading below levels last seen during the global financial crisis and at less than half its long-term average price-to-book multiple. The auto sector has generally been out of favour due to concerns about electrification, self-driving cars, and the economic cycle and Honda has also suffered from its own share of specific challenges in recent years.

The market appears to be extrapolating these trends forward and assuming that Honda's fortunes can never improve. If we take a bottom-up view of the business, we can construct a more sober view of Honda's intrinsic value.

Even in tough conditions last year, we estimate that Honda's core automobile business generated approximately \$2.5 billion of net profit. Applying a depressed multiple of just five times to those depressed earnings would produce a value of \$12 billion. By adding another \$20 billion for Honda's conservatively managed automobile finance business and the \$18 billion of net cash on its balance sheet, the sum of those parts alone would account for more than Honda's current market cap of \$45 billion. But it would ignore Honda's most attractive asset.

While best known for its cars, Honda is the world's largest motorcycle manufacturer with a dominant (75%+) share in emerging markets such as Thailand, Vietnam, Indonesia and Brazil. Motorcycles now make up more than one third of Honda's profits compared to less than 15% a decade ago. Motorcycle profits have compounded at roughly 8% per annum over the past 15 years and the business earns double-digit margins. In our view, the motorcycle business adds another \$25 billion to Honda's intrinsic value. That takes our sum of the parts valuation to \$75 billion – implying roughly 60% upside to the current share price.

Of course, things can also get worse. Current trends toward electrification and autonomous vehicles could accelerate and prove to be much more disruptive and detrimental to Honda's competitive position than we expect. In the near term, global trade tensions or other macro developments could trigger a severe recession leading to considerably weaker car sales. While Honda's cash position is strong, there is always a risk of misallocation of capital.

Only time will tell, but we believe the risk-reward proposition with Honda is heavily skewed in our favour over the long term. When investors have already assumed the worst, there's often room for considerable upside even if things turn out merely "less bad" than feared.

The Orbis Optimal SA Fund's overall net equity exposure increased slightly over the quarter as the equity exposure to North America and Europe increased. Among individual positions, the largest addition was to Japanese car manufacturer, Honda. The largest sale was Celgene, a US biotechnology company.

Management Company

Allan Gray Unit Trust Management (RF) Proprietary Limited (the 'Management Company') is registered as a management company under the Collective Investment Schemes Control Act 45 of 2002, in terms of which it operates 11 unit trust portfolios under the Allan Gray Unit Trust Scheme, and is supervised by the Financial Sector Conduct Authority ('FSCA'). The Management Company is incorporated under the laws of South Africa and has been approved by the regulatory authority of Botswana to market its unit trusts in Botswana, however it is not supervised or licensed in Botswana. Allan Gray Proprietary Limited (the 'Investment Manager'), an authorised financial services provider, is the appointed Investment Manager of the Management Company and is a member of the Association for Savings & Investment South Africa ('ASISA'). The trustee/custodian of the Allan Gray Unit Trust Scheme is Rand Merchant Bank, a division of FirstRand Bank Limited. Fund mandate

The Fund may be closed to new investments at any time in order to be managed according to its mandate. Unit trusts are traded at ruling prices and can engage in borrowing and scrip lending. The Fund may borrow up to 10% of its market value to bridge insufficient liquidity.

Unit price

Unit trust prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund including any income accruals and less any permissible deductions from the Fund divided by the number of units in issue.

Forward pricing is used and fund valuations take place at approximately 16:00 each business day. Purchase and redemption requests must be received by the Management Company by 14:00 each business day to receive that day's price. Unit trust prices are available daily on www.allangray.co.za

Fees

Permissible deductions may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and trustee fees. A schedule of fees, charges and maximum commissions is available on request from Allan Gray.

Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged), VAT and other expenses like audit and trustee fees. Transaction costs (including brokerage, Securities Transfer Tax [STT], STRATE and Investor Protection Levy and VAT thereon) are shown separately. Transaction costs are a necessary cost in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of financial product, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. As unit trust expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and Transaction costs is shown as the Total investment charge ('TIC').

Fund of funds

A fund of funds is a unit trust that invests in other unit trusts, which charge their own fees. Allan Gray does not charge any additional fees in its funds of funds.

Foreign exposure

The Fund invests in foreign funds managed by Orbis Investment Management Limited, our offshore investment partner.
