Fund description

The Fund invests in a focused portfolio of companies with significant business interests in Africa, regardless of the location of the stock exchange listing. The Fund price is reported in US dollars but the underlying holdings are denominated in various currencies. Returns are likely to be volatile.

Fund objective and benchmark

The Fund aims to outperform African equity markets over the long term without taking on greater risk of loss. The Fund's benchmark is the MSCI Emerging and Frontier Markets (EFM) Africa Index (total returns).

How we aim to achieve the Fund's objective

We invest in shares that we believe offer superior fundamental value while taking into account risk and return. We research companies and assess their intrinsic value based on long-term fundamentals; we then invest in businesses where our assessment of intrinsic value exceeds the share price by a margin of safety. This approach allows us to identify shares that may be out of favour with the market because of poor near-term prospects, but offer good value over the long-term. The Fund's holdings will deviate meaningfully from those in the index both in terms of individual holdings and sector exposure.

Suitable for those investors who

- Seek exposure to African equities
- Are comfortable with stock market and currency fluctuations
- Are prepared to take the risk of capital loss
- Typically have an investment horizon of more than five years

The Fund is not available to South African residents.


Annual management fee

The annual management fee ranges from 0.5% to 2.5% depending on the relative return of the Fund to the benchmark, before fees. The fee is calculated on a base of 1.5% plus one twenty-fifth of the cumulative threeyear relative performance, subject to a floor of 0.5% and cap of 2.5%. For example if the cumulative three year performance of the fund is 20% and that of the benchmark is 15%, the fee rate is: 1.5% + (20%-15%)/25 = 1.7%.

Fund manager quarterly commentary as at 30 September 2012

The past quarter was a stable one in terms of changes to the portfolio. Both the country allocations as well as the individual holdings in each country were basically unchanged. We continuously search for the most attractive investment opportunities and reassess our investments but the price changes of the past quarter did not justify major position changes.

The Fund's holdings are very different from those of the benchmark with the most noticeable difference being the Fund's underweight position in the South African retail sector. South African food and apparel retailers have experienced a remarkable period of earnings growth and multiple expansion. Revenues for the three largest food retailers and the three largest clothing retailers have risen by approximately 15% per year for the past decade; this compares to consumer price inflation of 6% over the past eleven years. The profit expansion is even more stark with the weighted average margin for these clothing retailers increasing from 8.5% to 22%, resulting in a 25% compound annual growth rate (CAGR) in operating profit. Consolidated profits in the food retail sector have risen 21% per year. The retailers are high quality businesses with potentially more growth to come, but is it probably safe to assume that profits are now high. In early 2001 investors placed an average price earnings multiple of 12 on these profits but the average multiple has now increased to 24. In our opinion the combination of high multiples on high earnings is a dangerous one and something we try to avoid, hence the Fund's zero weighting in South African retail shares compared to 9.3% in the benchmark.
