# Fund description and summary of investment policy

The Fund invests in a focused portfolio of companies with significant business interests in Africa, regardless of the location of the stock exchange listing. The Fund price is reported in US dollars but the underlying holdings are denominated in various currencies. Returns are likely to be volatile.

# Fund objective and benchmark

The Fund aims to outperform African equity markets over the long term without taking on greater risk of loss. The Fund's benchmark is the MSCI Emerging and Frontier Markets (EFM) Africa Index (total returns).

# How we aim to achieve the Fund's objective

We invest in shares that we believe offer superior fundamental value while taking into account risk and return. We research companies and assess their intrinsic value based on long-term fundamentals; we then invest in businesses where our assessment of intrinsic value exceeds the share price by a margin of safety. This approach allows us to identify shares that may be out of favour with the market because of poor near-term prospects, but offer good value over the long term. The Fund's holdings will deviate meaningfully from those in the index both in terms of individual holdings and sector exposure.

### Suitable for those investors who

- Seek exposure to African equities
- Are comfortable with stock market and currency fluctuations
- Are prepared to take on the risk of capital loss
- Typically have an investment horizon of more than five years

### Capacity

The Fund has limited capacity and thus may restrict inflows. Redemptions may be limited to US\$5m or 2.5% of the Fund (whichever is less) per dealing day.

# Fair value pricing

The board of directors of the Fund ('the board') may fair value the Fund's assets in accordance with the board's fair value pricing policies if:

- the closing market quotations or official closing prices are not readily available or do not accurately reflect the fair value of a Fund asset; or
- the value of a Fund asset has been materially affected by events occurring before the Fund's pricing time but after the close of the exchange or market on which the asset is principally traded.

The board delegates the responsibility for fair value pricing decisions to a Valuation Committee of the Investment Manager.



# Subscription and redemption charge

Investors may be charged 0.5% when subscribing for Fund shares. Investors may be charged 0.5% when redeeming Fund shares in the case of significant redemptions. These charges are paid into the Fund to offset the costs associated with the transactions that are borne by the Fund. The Investment Manager may waive these charges if transactions substantially offset one another.

# Annual management fee

The management fee consists of a base fee of 1% and a performance component. The fee rate is calculated weekly by comparing the Fund's total performance for the week, after the base fee is deducted, to that of the benchmark.

Fee for performance equal to the Fund's benchmark: 1.00% p.a.

For each percentage point above or below the benchmark we add or deduct 0.2%. This means that Allan Gray shares in approximately 20% of the performance relative to the benchmark.

The fee is capped at 5% over any 12 month rolling period and can decrease to a minimum of 0%. If the fee would have been negative, the negative fee will be carried forward to reduce the next week's fee (and all subsequent weeks until the underperformance is recovered).

# Total expense ratio (TER) and Transaction costs<sup>6</sup>

The annual management fee charged is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

After a weak 2018, selected African markets had a decent start to the year, in particular, Kenya, Egypt, and South Africa. Unfortunately, our Fund has a modest exposure to Kenyan equities as we are concerned about the sustainability of the managed currency, which has remained around KES101 to the US dollar for the past three and a half years. Nigeria was the worst-performing major African market, falling a further 1% after an 18% decline in 2018. This happens to be the market where we find the most value.

The South African market was a tale of two parts: The domestically orientated shares were weak in the first quarter, with retailers falling 14% and banks down 1%, while resource shares were very strong, appreciating 18%. The Fund is very underweight in South Africa as we have not found value in domestic companies, but this is beginning to change given the recent price action. Our resources exposure is predominantly to what we think are undervalued oil companies, rather than the very iron-ore-heavy companies, such as Anglo American and BHP Billiton, which have driven the recent rally.

The Nigerian presidential election, held in February, was disappointing for a few reasons. The main candidates were of a particularly low quality: The incumbent, President Muhammadu Buhari, delivered very little in his first term and the challenger, Atiku Abubakar, has a chequered history. The election was delayed by a week on the eve of the scheduled date and Nigerians seem to have lost hope in the possibility of meaningful change, with voter turnout falling across the country and reaching lows of 17% in the economically dominant Lagos State.

The above, together with the tepid economic recovery and the seemingly spurious pursuit of many multi-national companies by Nigerian tax authorities, means that investor sentiment towards Nigeria has reached new lows. However, despite the bleak outlook, we think there is good value in the equity market. We favour the banks, but certain consumer companies are also beginning to show some value.

Access Bank of Nigeria, a top 10 position in the Fund, made a bid for Diamond Bank in December 2018. Shareholders approved the transaction in March. Many investors were sceptical of the thinking behind the deal and the high price Access

offered for Diamond. We too were concerned but, after lengthy discussions with the Access management, we came to appreciate their line of thinking. Diamond's low-cost deposit base is valuable and the system integration should be relatively straightforward given that the systems are very similar. As a result, we voted in favour of the acquisition. Twelve months ago, Access' share price was NGN11.05, compared to the current NGN6.45 – despite Access growing earnings by 52% to NGN3.25 per share in 2018. Granted, these earnings are high and will likely fall in 2019, but we think there is substantial value in the share and a sufficient margin of safety to compensate for the Nigerian risks.

The Zimbabwean government has recently started moving in the right direction on the currency. Rather than sticking to the supposed 1:1 peg they have introduced a new currency exchange rate known as Real Time Gross Transfers dollars or RTGS rate, which is slowly moving towards the black market rate. The 28 March RTGS rate was 3.1 compared to the black market rate of about 4.1. It is not possible for investors to transact at the RTGS rate as there is very limited liquidity available. If in time the RTGS becomes a liquid and open market, we will use this exchange rate and official market prices to value the Zimbabwean holdings. For now, we still hold the Zimbabwean equities at our fair values.

The portfolio holdings have been reasonably stable over the past quarter and year, as we think the companies we hold still trade at a substantial discount to fair value. As such, we have had no reason to rotate the portfolio. The good thing is that we don't need sentiment towards African markets or our stocks to change for the portfolio to generate solid real returns. The valuations are such that the dividend yield of the Fund exceeds 5.3% allowing for plenty of real return through the dividend yields alone.

### Fund information

The Fund is incorporated and registered under the laws of Bermuda and is supervised by the Bermuda Monetary Authority. The Fund is also listed on the Bermuda Stock Exchange. The primary custodian of the Fund is Citibank N.A. The custodian can be contacted at 390 Greenwich Street, New York, New York, USA. The Investment Manager of the Fund is Allan Gray Bermuda Limited.

The Fund may be closed to new investments at any time to be managed according to its mandate. Shares in the Fund are traded at ruling prices and the Fund can engage in borrowing and scrip lending. The Fund may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. This report does not constitute a financial promotion, a recommendation, an offer to sell or a solicitation to buy shares in the Fund. Investments in the Fund are made according to the terms and conditions and subject to the restrictions set out in the prospectus. ### Share price

Share prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund including any income accruals and less any permissible deductions from the Fund divided by the number of shares in issue. Forward pricing is used. The weekly price of the Fund is normally calculated each Friday. Purchase requests must be received by the Registrar of the Fund (being Citibank Europe plc, Luxembourg Branch) by 17:00 Bermuda time on that dealing day to receive that week's price. Redemption requests must be received by the Registrar of the Fund by 12:00 Bermuda time, on the particular dealing day on which shares are to be redeemed to receive that week's price. ### Fees and charges

Permissible deductions from the Fund may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and custody fees. A schedule of fees, charges and maximum commissions is available on request from the Allan Gray Service Team.

### Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged) and other expenses like audit fees. Transaction costs (including brokerage, Securities Transfer Tax [STT] and investor protection levies where applicable) are shown separately. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. As collective investment scheme expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and Transaction costs is shown as the Total investment charge (TIC).

### Foreign exposure

Such contract counterparty risk is accentuated for contracts with longer maturities where events may intervene to prevent settlement, or where the Fund has concentrated its transactions with a single or small group of counterparties. Borrowing, leveraging, and trading securities on margin will result in interest charges and, depending on the amount of trading activity, such charges could be substantial. The low margin deposits normally required in futures and forward trading, which the Fund may utilise, permit a high degree of leverage. As a result, a relatively small price movement in a futures or forward contract may result in immediate and substantial losses to the investor.
