Fund description and summary of investment policy

The Fund invests in a focused portfolio of companies with significant business interests in Africa, regardless of the location of the stock exchange listing. The Fund price is reported in US dollars but the underlying holdings are denominated in various currencies. Returns are likely to be volatile.

Fund objective and benchmark

The Fund aims to outperform African equity markets over the long term without taking on greater risk of loss. The Fund's benchmark is the MSCI Emerging and Frontier Markets (EFM) Africa Index (total returns).

How we aim to achieve the Fund's objective

We invest in shares that we believe offer superior fundamental value while taking into account risk and return. We research companies and assess their intrinsic value based on long-term fundamentals; we then invest in businesses where our assessment of intrinsic value exceeds the share price by a margin of safety. This approach allows us to identify shares that may be out of favour with the market because of poor near-term prospects, but offer good value over the long term. The Fund's holdings will deviate meaningfully from those in the index both in terms of individual holdings and sector exposure.

Suitable for those investors who

- Seek exposure to African equities
- Are comfortable with stock market and currency fluctuations
- Are prepared to take on the risk of capital loss
- Typically have an investment horizon of more than five years

Capacity

The Fund has limited capacity and thus may restrict inflows. Redemptions may be limited to US\$5m or 2.5% of the Fund (whichever is less) per dealing day.

Fair value pricing

The board of directors of the Fund ('the board') may fair value the Fund's assets in accordance with the board's fair value pricing policies if:

- the closing market quotations or official closing prices are not readily available or do not accurately reflect the fair value of a Fund asset; or
- the value of a Fund asset has been materially affected by events occurring before the Fund's pricing time but after the close of the exchange or market on which the asset is principally traded.

The board delegates the responsibility for fair value pricing decisions to a Valuation Committee of the Investment Manager.



Subscription and redemption charge

Investors may be charged 0.5% when subscribing for Fund shares. Investors may be charged 0.5% when redeeming Fund shares in the case of significant redemptions. These charges are paid into the Fund to offset the costs associated with the transactions that are borne by the Fund. The Investment Manager may waive these charges if transactions substantially offset one another.

Annual management fee

The management fee consists of a base fee of 1% and a performance component. The fee rate is calculated weekly by comparing the Fund's total performance for the week, after the base fee is deducted, to that of the benchmark.

Fee for performance equal to the Fund's benchmark: 1.00% p.a.

For each percentage point above or below the benchmark we add or deduct 0.2%. This means that Allan Gray shares in approximately 20% of the performance relative to the benchmark.

The fee is capped at 5% over any 12 month rolling period and can decrease to a minimum of 0%. If the fee would have been negative, the negative fee will be carried forward to reduce the next week's fee (and all subsequent weeks until the underperformance is recovered).

Total expense ratio (TER) and Transaction costs⁶

The annual management fee charged is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

The past 18 months has been a difficult period for the Fund, with a 27% drawdown from the April 2018 price. This performance is clearly disappointing but the encouraging, in fact exciting, aspect is that the price change is not a reflection of permanent losses, but rather positions de-rating sharply. The most significant detractors over the period were the Nigerian banks and all of the Zimbabwean holdings.

From December 2016, Zimbabwe was in a hyperinflationary situation and the currency was pegged at parity to the US dollar, so we held our Zimbabwean positions at fixed fair values. In February 2019, Zimbabwe moved the peg to 2.5 but still managed the currency. By July, the official rate began to reflect reality, so we moved the portfolio pricing to market prices. Since July, the Zimbabwe dollar has depreciated from ZWL9/US\$ to ZWL15.2/US\$. The government claims to be running a balanced budget, but if this was the case, the currency would have found a floor.

Until recently, the prices of our Zimbabwean holdings did not move in local currency and therefore fell sharply in US dollars. For example, Delta Corporation, the monopoly brewer in Zimbabwe, fell from US\$0.40 in July to US\$0.22 in September, before recovering to US\$0.26, compared to our fair value of US\$0.64. The market capitalisation is now US\$336m. The Zimbabwean economic situation is dire, but Delta will survive, and people will drink beer. As such, we think a conservative free cash flow number for Delta in a vaguely normal environment is US\$50m. Similar logic and valuations apply to our two other significant positions, telecommunications group Econet Wireless and Cassava Smartech.

Zimbabwean shares made up 17% of the Fund in April 2018, compared to 13% today. In aggregate, the prices of the Zimbabwean securities are down 47%. Despite the deteriorating economic situation in Zimbabwe, we still think our 2018 fair values are appropriate and see substantial upside from current prices.

Nigerian banks account for 21% of the Fund. The various Nigerian banks are down between 33% and 55% since April 2018. The regulatory environment has become more difficult as the Central Bank of Nigeria has put additional onerous and costly burdens on the sector. The hostile regulatory environment is well known, and the sector has de-rated accordingly. Over time, banks can usually adjust to changing regulatory environments and maintain similar levels of profitability. Zenith Bank, our largest holding, is down from NGN27.50 to NGN18.70 over the past 18 months, despite earnings in the first half of 2019 growing 8% on the 2018 H1 base. As a result, the price-to-earnings multiple has gone from 5.2 to 3.1 times. The 0.7 price-to-book multiple compares to the 10-year average of 1.1. Fortunately, we don't need sentiment to turn positive for the Nigerian banks to be rewarding investments. The healthy dividend yields, 15% in the case of Zenith, should provide ample reward.

We are very excited about the portfolio and the probability of substantial real returns.

Over the quarter, we sold Acacia Mining and Multichoice and purchased Guaranty Trust Bank and Glencore.

Fund information

The Fund is incorporated and registered under the laws of Bermuda and is supervised by the Bermuda Monetary Authority. The Fund is also listed on the Bermuda Stock Exchange. The primary custodian of the Fund is Citibank N.A. The custodian can be contacted at 390 Greenwich Street, New York, New York, USA. The Investment Manager of the Fund is Allan Gray Bermuda Limited.

The Fund may be closed to new investments at any time to be managed according to its mandate. Shares in the Fund are traded at ruling prices and the Fund can engage in borrowing and scrip lending. The Fund may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. This report does not constitute a financial promotion, a recommendation, an offer to sell or a solicitation to buy shares in the Fund. Investments in the Fund are made according to the terms and conditions and subject to the restrictions set out in the prospectus. The offering of shares in the Fund may be restricted in certain jurisdictions. Please contact the Allan Gray service team to confirm if there are any restrictions that apply to you.

Share price

Purchase requests must be received by the Registrar of the Fund (being Citibank Europe plc, Luxembourg Branch) by 17:00 Bermuda time on that dealing day to receive that week's price. Redemption requests must be received by the Registrar of the Fund a time, on the particular dealing day on which shares are to be redeemed to receive that week's price. Fees and charges

Permissible deductions from the Fund may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and custody fees. A schedule of fees, charges and maximum commissions is available on request from the Allan Gray Service Team.

Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged) and other expenses like audit fees. Transaction costs (including brokerage, Securities Transfer Tax [STT] and investor protection levies where applicable) are shown separately. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. As collective investment scheme expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The low margin deposits normally required in futures and forward trading, which the Fund may utilise, permit a high degree of leverage. As a result, a relatively small price movement in a futures or forward contract may result in immediate and substantial losses to the investor.
