Fund description and summary of investment policy

The Fund invests in a focused portfolio of companies with significant business interests in Africa, regardless of the location of the stock exchange listing. The Fund price is reported in US dollars but the underlying holdings are denominated in various currencies. Returns are likely to be volatile.

Fund objective and benchmark

The Fund aims to outperform African equity markets over the long term without taking on greater risk of loss. The Fund's benchmark is the MSCI Emerging and Frontier Markets (EFM) Africa Index (total returns).

How we aim to achieve the Fund's objective

We invest in shares that we believe offer superior fundamental value while taking into account risk and return. We research companies and assess their intrinsic value based on long-term fundamentals; we then invest in businesses where our assessment of intrinsic value exceeds the share price by a margin of safety. This approach allows us to identify shares that may be out of favour with the market because of poor near-term prospects, but offer good value over the long term. The Fund's holdings will deviate meaningfully from those in the index both in terms of individual holdings and sector exposure.

Suitable for those investors who

- Seek exposure to African equities
- Are comfortable with stock market and currency fluctuations
- Are prepared to take on the risk of capital loss
- Typically have an investment horizon of more than five years

Capacity

The Fund has limited capacity and thus may restrict inflows. Redemptions may be limited to US\$5m or 2.5% of the Fund (whichever is less) per dealing day.

Fair value pricing

The board of directors of the Fund ('the board') may fair value the Fund's assets in accordance with the board's fair value pricing policies if:

- the closing market quotations or official closing prices are not readily available or do not accurately reflect the fair value of a Fund asset; or
- the value of a Fund asset has been materially affected by events occurring before the Fund's pricing time but after the close of the exchange or market on which the asset is principally traded.

The board delegates the responsibility for fair value pricing decisions to a Valuation Committee of the Investment Manager.

Subscription and redemption charge

Investors may be charged 0.5% when subscribing for Fund shares. Investors may be charged 0.5% when redeeming Fund shares in the case of significant redemptions. These charges are paid into the Fund to offset the costs associated with the transactions that are borne by the Fund. The Investment Manager may waive these charges if transactions substantially offset one another.

Annual management fee

The management fee consists of a base fee of 1% and a performance component. The fee rate is calculated weekly by comparing the Fund's total performance for the week, after the base fee is deducted, to that of the benchmark.

Fee for performance equal to the Fund's benchmark: 1.00% p.a.

For each percentage point above or below the benchmark we add or deduct 0.2%. This means that Allan Gray shares in approximately 20% of the performance relative to the benchmark.

The fee is capped at 5% over any 12 month rolling period and can decrease to a minimum of 0%. If the fee would have been negative, the negative fee will be carried forward to reduce the next week's fee (and all subsequent weeks until the underperformance is recovered).

Total expense ratio (TER) and Transaction costs⁶

The annual management fee charged is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

Allan Gray Africa Equity Fund

The Fund returned 56% in US dollars over the past year. This strong performance masks what has been a tumultuous 18 months and indeed challenging five years for African markets. Over the past five years, the MSCI Emerging and Frontier Markets Africa Index has delivered a total return of 4.1% per annum. While returns have been positive, they are materially below those of many global markets, with the MSCI World Index generating a return of 14.8% per annum over the past five years.

Perhaps more concerning, most African countries are materially behind their Western peers when it comes to COVID-19 vaccinations. While countries like the UK, Hungary, Germany and the US have fully vaccinated more than 35% of their populations, countries in Africa, such as South Africa, Nigeria, Egypt and Kenya have fully vaccinated less than 3%. It is therefore likely that full economic recovery in many of these markets will lag more developed markets for some time to come.

That is the bad news.

The good news is that this negative sentiment is more than priced in. In the popular markets today, such as the Nasdaq, the overwhelming focus of investors is on growth and missed opportunities. In Africa, it is the opposite. Conversations about investments are dominated by front-of-mind risks, including politics, the economy, the currency, or some other factors. For many, Africa is simply uninvestable.

But superior investment returns do not arise from avoiding all risks; they arise from managing risks. The goal is to expose yourself to asymmetric payoffs where, given the risks, the odds and payoff of a favourable outcome materially outweigh the odds and payoff of an unfavourable outcome. One of the key ways an investor can skew the odds in their favour, is to pay a sufficiently low price at inception. As it so happens, valuations in Africa today are extremely attractive, particularly in comparison to global peers. A lot can go wrong in many African countries and the companies therein may still generate superior investment returns, given starting valuations.

Our investments in African banks provide an apt example. We own various banks across Africa, with our largest investments being in Nigeria, Kenya and South Africa. On average, in comparison to the large European and US banks, these banks have higher returns on equity (ROE), higher capital adequacy ratios, higher net interest margin buffers and higher historical growth rates. They also operate in far less mature markets, suggesting they have far greater runways for growth, and yet they trade at discounts of more than 50%. Zenith Bank in Nigeria, for example, has grown earnings by 9% per annum in US dollars at an average ROE of 20% over the last decade, yet it trades on just 3.2 times earnings. Bank of America, in comparison, has had an average ROE of less than half that over the same period, but it trades on 17 times earnings.

As Benjamin Graham famously said: "In the short run, the market is a voting machine, but in the long run, it is a weighing machine."

As we mentioned in the previous quarter, a large part of the Fund's year-to-date performance is related to a rally in Zimbabwean stocks, and this continues to be the case. While the currency appears to be stabilising, access to forex markets has improved, and the economic situation is the most promising we have seen it in years, the speed at which stocks have rallied does concern us. The volatility in Zimbabwean stocks could be a sign of a flight to safety within Zimbabwe, as investors seek protection in real assets. As a result, during the quarter we updated our estimate of fair value for each stock in Zimbabwe in which our clients are invested, and have once again moved to pricing our investments in Zimbabwe at the lower of market prices or our own internal estimate.

During the quarter we increased our exposure to select South African shares.

Fund information

The Fund is incorporated and registered under the laws of Bermuda and is supervised by the Bermuda Monetary Authority. The Fund is also listed on the Bermuda Stock Exchange. The primary custodian of the Fund is Citibank N.A. The custodian can be contacted at 390 Greenwich Street, New York, New York, USA. The Investment Manager of the Fund is Allan Gray Bermuda Limited.

The Fund may be closed to new investments at any time to be managed according to its mandate. Shares in the Fund are traded at ruling prices and the Fund can engage in borrowing and scrip lending. The Fund may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. This report does not constitute a financial promotion, a recommendation, an offer to sell or a solicitation to buy shares in the Fund. Investments in the Fund are made according to the terms and conditions and subject to the restrictions set out in the prospectus. Share price

Share prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund including any income accruals and less any permissible deductions from the Fund divided by the number of shares in issue. Forward pricing is used. The weekly price of the Fund is normally calculated each Friday. Purchase requests must be received by the Registrar of the Fund by 17:00 South African time on the particular dealing day on which shares are to be redeemed to receive that week's price.

Fees and charges

Permissible deductions from the Fund may include management fees, brokerage, securities transfer tax, auditor's fees, bank charges and custody fees. A schedule of fees, charges and maximum commissions is available on request from the Allan Gray service team.

Total expense ratio (TER) and transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one- and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged) and other expenses like audit fees. Transaction costs (including brokerage, securities transfer tax and investor protection levies where applicable) are shown separately. Transaction costs are necessary costs in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time, including market returns, the type of fund, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and transaction costs should not be deducted again from published returns. As collective investment scheme expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund.
