### Fund description and summary of investment policy

The Fund invests in a focused portfolio of African (excluding South Africa) securities that are selected for their expected risk and return profile. The Fund may invest a substantial portion of the assets in a single country or region rather than a diversified portfolio of assets.

### Fund objective and benchmark

The Fund seeks to achieve the maximum US dollar total return while minimising the risk of loss within the context of an African bond fund. The benchmark is the J.P. Morgan GBI-EM Global Diversified Index. The Fund does not seek to mirror the benchmark but instead may deviate meaningfully from this performance benchmark in pursuit of superior returns. To the extent that its investments differ from those in the benchmark, the Fund faces the risk of underperforming the benchmark.

#### How we aim to achieve the Fund's objective

We assess an asset's intrinsic value based on long-term fundamentals and invest where our assessment of intrinsic value exceeds the price by a margin of safety. This approach allows us to identify assets that may be out of favour with the market because of poor near-term prospects, but offer good value over the long term. The Fund's holdings may deviate meaningfully from those in the index.

#### Suitable for those investors who

- Seek exposure to African interest bearing assets
- Are comfortable with market and currency fluctuations
- Are prepared to take on the risk of capital loss
- Typically have an investment horizon of more than five years



### Fund manager quarterly commentary as at 30 June 2016

The Fund has returned 2.6% in dollars since inception in March 2013. This is disappointing in absolute terms but pleasing relative to the poor performance of many African investments over the same period. As an example, the yield on Zambian and Ghanaian bonds is today double what it was when the Fund started, while the Zambian kwacha and Ghanaian cedi have halved versus the dollar. US\$100 invested in a 5-year Zambian local currency bond at the inception of the Fund is worth just US\$40 today, resulting in a 35% cumulative loss, including coupon payments. We are pleased to have preserved capital in this environment, and look forward to improved absolute returns going forward.

As mentioned last quarter, the Fund has material exposure to Nigerian bank debt. This is all dollar denominated, which prevented losses from the recent naira depreciation. The Fund's exposure is weighted towards senior bonds issued by Tier 1 banks, which have outperformed higher-risk bonds. For example, the price of Access Bank senior bonds has remained at par over the last year, while the price of Access Bank subordinated bonds has fallen by more than 20%.

The yield on Nigerian bank subordinated bonds is now more than double the yield on senior bonds. We believe this compensates for the higher risk and have selectively invested in subordinated bonds. In addition to the attractive valuation, we expect the new naira exchange rate regime to be positive for banks over the long term. Dollar liquidity should stimulate economic activity, while a weaker naira should result in higher inflation and nominal yields. Bank profitability may suffer in the short term, but should ultimately benefit via higher demand for funding and funding spreads. If this is the case, subordinated bonds offering double digit dollar yields are attractive investments.

There was limited activity over the quarter. The Fund sold its holdings in Ethiopian sovereign debt due to concerns over the long-term sustainability of government finances, and invested the proceeds in Ivory Coast eurobonds. As mentioned above, the Fund also invested in Nigerian bank subordinated bonds. We continue to limit risk by favouring hard currency over local currency exposure, and holding a reasonable amount of cash.

#### Fees and charges

Permissible deductions from the Fund may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and custody fees. A schedule of fees, charges and maximum commissions is available on request from the Representative.

#### Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past three years. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged) and other expenses like audit fees. Transaction costs (including brokerage, Securities Transfer Tax [STT] and investor protection levies where applicable) are shown separately. There are no explicit brokerage charges in global bond markets. The broker rather takes an undisclosed spread between substantial depending on the asset and market circumstances. The disclosed transaction charge is therefore zero but in reality there are transaction costs which reflect in the Fund's returns. We aim to minimise costs by keeping our trading activity to a minimum and always seeking out the most favourable price when buying and selling assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.
