Fund description and summary of investment policy

The Fund invests in a focused portfolio of companies with significant business interests in Africa regardless of the location of the stock exchange listing (excluding South Africa). The Fund price is reported in US dollars, but the underlying holdings are denominated in various currencies. Returns are likely to be volatile.

Fund objective and benchmark

The Fund aims to outperform African equity markets over the long term without taking on greater risk of loss. The Fund's benchmark is the Standard Bank Africa Total Return Index. The Fund does not seek to mirror the benchmark but instead may deviate meaningfully from this performance benchmark in pursuit of superior returns. To the extent that its investments differ from those in the benchmark, the Fund faces the risk of underperforming the benchmark.

How we aim to achieve the Fund's objective

We invest in shares that we believe offer superior fundamental value while taking into account risk and return. We research companies and assess their intrinsic value based on long-term fundamentals; we then invest in businesses where our assessment of intrinsic value exceeds the share price by a margin of safety. This approach allows us to identify shares that may be out of favour with the market because of poor near-term prospects, but offer good value over the long term. The Fund's holdings will deviate meaningfully from those in the index both in terms of individual holdings and sector exposure.

Suitable for those investors who

- Seek exposure to African (excluding South African) equities
- Are comfortable with stock market and currency fluctuations
- Are prepared to take on the risk of capital loss
- Typically have an investment horizon of more than five years

Capacity

The Fund has limited capacity and is thus restricting inflows. Redemptions may be limited to US\$5m or 2.5% of the Fund (whichever is less) per dealing day.

Fair value pricing

The board of directors of the Fund ('the board') may fair value the Fund's assets in accordance with the board's fair value pricing policies if:

- the closing market quotations or official closing prices are not readily available or do not accurately reflect the fair value of a Fund asset; or
- the value of a Fund asset has been materially affected by events occurring before the Fund's pricing time but after the close of the exchange or market on which the asset is principally traded.

The board delegates the responsibility for fair value pricing decisions to a Valuation Committee of the Investment Manager.

Meeting the Fund objective

The Fund aims to outperform African equity markets (excluding South Africa) over the long term without taking on greater risk of loss. The Fund experiences periods of underperformance in pursuit of this objective. Since inception the Fund has outperformed its benchmark by a significant margin. The maximum drawdown and lowest annual return numbers, in the 'Performance in US\$ net of all fees and expenses' table, show that the Fund has not experienced more downside than its benchmark in periods of negative market returns. We believe our philosophy of buying undervalued equities should generate positive absolute returns over time

Subscription and redemption charge

Investors may be charged 1% when subscribing for Fund shares. Investors may be charged 1% when redeeming Fund shares in the case of significant redemptions. These charges are paid into the Fund to offset the costs associated with the transactions that are borne by the Fund. The Investment Manager may waive these charges if transactions substantially offset one another.

Annual management fee

The management fee consists of a base fee of 0.7% and a performance component. The fee rate is calculated weekly by comparing the Fund's total performance for the week, after the base fee is deducted, to that of the benchmark.

Fee for performance equal to the Fund's benchmark: 0.70% p.a.

For each percentage point above or below the benchmark we add or deduct 0.2%. This means that Allan Gray shares in approximately 20% of the performance relative to the benchmark.

The fee is capped at 4.7% over any 12 month rolling period and can decrease to a minimum of 0%. If the fee would have been negative, the negative fee will be carried forward to reduce the next week's fee (and all subsequent weeks until the underperformance is recovered).

Total expense ratio (TER) and Transaction costs

The annual management fee charged is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately. The TER and Transaction costs cannot be determined accurately because of the short life span of the class. Calculations are based on actual data where possible and best estimates where actual data is not available.

African equities have disappointed year to date. While international equity markets have recovered sharply from the March lows, African markets made only a modest recovery. The MSCI World Index is down 6% year to date, compared to declines of 23% for the Egyptian market, 13% for Kenya and 17% for Morocco. The Standard Bank Africa Index (SBAI) has done well as gold shares, which account for 27%, have performed exceptionally.

Nigerian banks are 2020's biggest detractors by some margin. We touched on the valuations in the March commentary, and we still think there is exceptional value. Unfortunately, the Nigerian regulator is steadily adding to the regulatory burden, which flows through to profitability and investor sentiment. We think the current burdens, and more, are reflected in the valuations.

Caledonia Mining, the biggest contributor to date in 2020, benefited from the rising gold price. In addition, Caledonia will shortly begin ramping up its long-term expansion project, which should boost production from 55 000 to 80 000 ounces over the next 18 months. Caledonia was very undervalued and did not need a higher gold price for the investment to make sense but, if ever there was a case for gold, it is now. With central banks aggressively trying to debase their currencies, the argument for hard assets is clear. That said, gold is just one of many hard assets and the price of gold relative to other assets is high. There is always a chance that gold rises spectacularly as it did in 1980, but these are not odds we are willing to back. Gold shares account for 27% of the Fund's benchmark and these shares have all done extremely well. We do not manage the Fund in a benchmark-cognisant manner and have started reducing our Caledonia exposure as the share approaches fair value.

Two of the larger positions we have not previously discussed are telecommunications company Sonatel and energy provider Umeme. Sonatel is an Orange subsidiary operating in Francophone West Africa. Its share price has halved since 2017, despite earnings only falling 6% and steady revenue growth. We think earnings will grow from here and the 7.5 price-to-earnings (PE) multiple

could rerate sharply. If there is no rerating, the 9.5% dividend yield will provide a decent return. Unlike many telcos, Sonatel has very little debt – net debt to earnings before interest, tax, depreciation and amortisation (EBITDA) is only 0.2 times. We have been buying the share over the past year.

Umeme administers the Ugandan power transmission grid on a 20-year concession, expiring in 2025. If the contract is not renewed, Umeme has the right to sell the assets back to the government at 105% of book value. The share trades at 50% of book value, three times earnings and yields 11.5%. We think it is likely that the concession will be renewed, and the risk/return profile is strongly skewed in our favour at this valuation.

About 16% of the Fund is invested on the Zimbabwean Stock Exchange. The Zimbabwean political and economic situation seems to reach ever-lower lows. We fair value our Zimbabwean holdings, as the official exchange rate and equity prices are not reflective of reality. We think valuations are conservative but, given the deteriorating situation, we have cut our valuations by 45% year to date.

In addition to the trades noted above, we bought some QN Bank in Egypt and switched some of our Nigerian bank holdings into MTN Nigeria.

Team changes

We plan to implement a portfolio manager change over the next few months. The Fund is currently managed by Andrew Lapping and Rory Kutisker-Jacobson. Andrew is leaving Allan Gray towards the end of the year after 20 years at the firm. This change allows the opportunity to promote two of our Africa team members, Kamal Govan and Rami Hajjar, to join Rory as portfolio managers. We are very excited about these appointments and know both Rami and Kamal will bring their skills to bear in identifying and adding undervalued assets to the portfolio.

Fund information

The Fund is incorporated and registered under the laws of Bermuda and is supervised by the Bermuda Monetary Authority. The Fund is also listed on the Bermuda Stock Exchange. The primary custodian of the Fund is Citibank N.A. The custodian can be contacted at 390 Greenwich Street, New York, New York, USA. The Investment Manager has appointed Allan Gray Unit Trust Management (RF) Proprietary Limited (the 'Representative') as its representative for the purpose of approval in terms of the Collective Investment Schemes Control Act 45 of 2002. The Representative is incorporated under the laws of South Africa and is supervised by the Financial Sector Conduct Authority ('FSCA').

The Fund may be closed to new investments at any time to be managed according to its mandate. Shares in the Fund are traded at ruling prices and the Fund can engage in borrowing and scrip lending. The Fund may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. This report does not constitute a financial promotion, a recommendation, an offer to sell or a solicitation to buy shares in the Fund. Investments in the Fund are made according to the terms and conditions and subject to the restrictions set out in the prospectus. The offering of shares in the Fund may be restricted in certain jurisdictions. Please contact the Allan Gray service team to confirm if there are any restrictions that apply to you. Class C shares are only available to certain eligible investors who are subject to an additional administration fee separately agreed with an Allan Gray Group entity.

Share price

Forward pricing is used. The weekly price of the Fund is normally calculated each Friday. Purchase requests must be received by the Registrar of the Fund (being Citibank Europe plc, Luxembourg Branch) by 17:00 Bermuda time on that dealing day to receive that week's price. Redemption requests must be received by the Registrar of the Fund by 12:00 Bermuda time, on the particular dealing day on which shares are to be redeemed to receive that week's price. Fees and charges

Permissible deductions from the Fund may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and custody fees. A schedule of fees, charges and maximum commissions is available on request from the Representative.

Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged) and other expenses like audit fees. Transaction costs (including brokerage, Securities Transfer Tax [STT] and investor protection levies where applicable) are shown separately. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. As collective investment scheme expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The sum of the TER and Transaction costs is shown as the Total investment charge (TIC).

Borrowing, leveraging, and trading securities on margin will result in interest charges and, depending on the amount of trading activity, such charges could be substantial. The low margin deposits normally required in futures and forward trading, which the Fund may utilise, permit a high degree of leverage. As a result, a relatively small price movement in a futures or forward contract may result in immediate and substantial losses to the investor.
