Fund description and summary of investment policy

The Fund invests in a focused portfolio of Frontier Market Equities. The Fund price is reported in US dollars, but the underlying holdings are denominated in various currencies. Returns are likely to be volatile.

Fund objective and benchmark

The Fund aims to outperform Frontier Markets over the long term without taking on greater risk of loss. The Fund's benchmark is the MSCI Frontier Emerging Markets (FEM) Index. The Fund does not seek to mirror the benchmark but instead may deviate meaningfully from this performance benchmark in pursuit of superior returns. To the extent that its investments differ from those in the benchmark, the Fund faces the risk of underperforming the benchmark.

There are significant risks involved in investing in Frontier Market Equities and thus there is no assurance that the investment approach of the Fund will be successful or that the Fund will achieve its investment objective.

How we aim to achieve the Fund's objective

We invest in equities that we believe offer superior fundamental value while taking into account risk and return. We research companies and assess their intrinsic value based on long-term fundamentals; we then invest in businesses where our assessment of intrinsic value exceeds the share price by a margin of safety. This approach allows us to identify shares that may be out of favour with the market because of poor near-term prospects, but offer good value over the long term. The Fund's holdings will deviate meaningfully from those in the index both in terms of individual holdings and sector exposure.

Suitable for those investors who

- Seek exposure to Frontier Market equities
- Are comfortable with stock market and currency fluctuations
- Are prepared to take on the risk of capital loss
- Typically have an investment horizon of more than five years

Capacity

The Fund currently has limited capacity. Allan Gray Bermuda Limited (the 'Investment Manager') may, at its discretion, refuse a subscription or phase a subscription into the Fund over a number of dealing days. The Investment Manager may, at its discretion, limit redemptions to US\$5m or 2.5% of the Fund (whichever is less) per dealing day.

Subscription and redemption charge


Investors may be charged 1% when subscribing for Fund shares. Investors may be charged 1% when redeeming Fund shares in the case of significant redemptions. These charges are paid into the Fund to offset the costs associated with the transactions that are borne by the Fund. The Investment Manager may waive these charges if transactions substantially offset one another.

Fair value pricing

The board of directors of the Fund ('the board') may fair value the Fund's assets in accordance with the board's fair value pricing policies if:

- The closing market quotations or official closing prices are not readily available or do not accurately reflect the fair value of a Fund asset
- The value of a Fund asset has been materially affected by events occurring before the Fund's pricing time but after the close of the exchange or market on which the asset is principally traded

The board delegates the responsibility for fair value pricing decisions to a Valuation Committee of the Investment Manager.

Meeting the Fund objective

The Fund aims to outperform Frontier Markets over the long term without taking on greater risk of loss. The Fund may experience periods of underperformance in pursuit of this objective. As the Fund is less than five years old it is too early to tell if it has met its objective.

Annual management fee

The management fee consists of a base fee of 0.7% and a performance component. The fee rate is calculated weekly by comparing the Fund's total performance for the week, after the base fee is deducted, to that of the benchmark.

Fee for performance equal to the Fund's benchmark: 0.7% p.a.

For each percentage point above or below the benchmark we add or deduct 0.2%. This means that Allan Gray shares in approximately 20% of the performance relative to the benchmark. The fee can decrease to a minimum of 0%. If the fee would have been negative, the negative fee will be carried forward to reduce the next week's fee (and all subsequent weeks until the underperformance is recovered).

Total expense ratio (TER) and Transaction costs

The annual management fee charged is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately. The TER and Transaction costs cannot be determined accurately because of the short life span of the class. Calculations are based on actual data where possible and best estimates where actual data is not available.

Allan Gray Frontier Markets Equity Fund

This time last year, just more than a third of the world's population had gone under lockdowns of varying intensity in response to the COVID-19 pandemic. Markets were quick to react to the heightened uncertainty and fear, with the Fund and the index falling 28.5% and 31.6% respectively in the first three months of 2020. At the time we believed the reaction to be overdone, and wrote:

"This uncertainty has created compelling opportunities for the long-term investor to buy great businesses at bargain-bin prices. We don't know if frontier assets will get cheaper, but we do know that they are currently trading at extremely attractive prices relative to history. For those with a long-term horizon and who are willing to stomach mark-to-market volatility in the short term, now should prove an extremely fruitful time to be allocating capital."

At the time of writing today, a substantial portion of the world remains under restrictions on individual freedom, as countries continue to battle with the virus and vaccines are being rolled out at considerably different speeds. We continue to have little clarity on when the world will return to normal, and what changes in behaviour may be permanent versus temporary. However, one thing has changed remarkably: market sentiment. Over the last year the Fund has delivered a return of 51.4% in US dollars, while the index has recovered some 33.6%. It pays to be greedy when others are fearful.

While we may not be as excited about the return prospects for our Fund as we were at this time last year, we continue to see substantial value both in the equities we find attractive, and in the markets in which we invest overall. Coming into the crisis, frontier markets were already unloved and out of favour, and so they fell from depressed levels at the start of 2020 to extremely depressed levels at the bottom in March 2020. In our humble opinion, they have simply recovered to depressed levels at the moment.

A review of two of the larger holdings in our Fund illustrates the point:

This time last year, Halyk Bank, the largest bank in Kazakhstan, traded on just 3.6 times historic earnings. We used the depressed market sentiment at that point in time to increase the Fund's exposure. Of course, Halyk was not unaffected by the COVID-19 crisis, providing materially for the likelihood of increased bad debts in the first and second quarter of 2020. However, being an oil economy, it emerged that the oil price was far more important to many of their corporate clients than the market possibly realised, and by the end of the 2020 financial year the bad debt situation had improved materially as the oil price recovered, with a number of large-ticket corporate loans being repaid in the fourth quarter of 2020. Despite the impact of COVID-19 on lending, corporate activity and bad debts, Halyk was actually able to grow earnings in the last financial year.

Today, the share price has recovered remarkably, but it continues to trade on an undemanding multiple of just 5 times earnings and a dividend yield north of 10%. We do not rule out the risk of the economic situation deteriorating and bad debts spiking down the line, but we believe the high profitability buffer and capital adequacy ratio of over 25% provide shareholders with significant protection. We continue to be happy Halyk shareholders.

On the commodity front, our largest single investment is in Zimplats, the platinum group metals (PGMs) miner located in Zimbabwe. Zimplats runs a low-cost, long-life, and highly profitable mine, that happens to be located in Zimbabwe. It is majority owned by Impala Platinum (listed in South Africa) and arguably the best mine in their stable. It remained profitable at the bottom of the PGM cycle in 2016 when many of the South African producers were heavily loss-making, and started 2020 off in a very healthy position, with net cash on the balance sheet and trading on just 5.4 times historic earnings. The PGM basket includes rhodium and palladium, whose prices went unaffected by the COVID-19 pandemic. Over the past 15 months, rhodium is up a staggering 340% while palladium is up 35%. Needless to say, profitability across the PGM sector is high, and Zimplats is no exception, with earnings up more than 210% year on year. The share price has similarly rallied, up some 136% in US dollars since the end of 2019. However, while Zimplats has rallied substantially, it continues to trade on an undemanding multiple and at a substantial discount to its South African peers. At spot PGM prices, it trades on less than 4.5 times our estimate of earnings, and around 15 times June 2019 earnings (a period when PGM prices were much lower). We believe normal is somewhere between these two numbers and continue to be happy shareholders.

Across our portfolio there are a number of similar companies, trading on depressed multiples and operating healthy and growing businesses. We anticipate that volatility in our markets is likely to be heightened for some time, but continue to be excited about the long-term prospects for outsized returns, particularly in comparison to developed markets.

During the quarter we increased our exposure to Georgia Capital and established a new position in LT Group in the Philippines. We reduced our exposure to Kenyan banks.

The Fund may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. This report does not constitute a financial promotion, a recommendation, an offer to sell or a solicitation to buy shares in the Fund. Investments in the Fund are made according to the terms and conditions and subject to the restrictions set out in the prospectus. Share price

Share prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund including any income accruals and less any permissible deductions from the Fund divided by the number of shares in issue. Forward pricing is used. The weekly price of the Fund is normally calculated each Friday. Purchase requests must be received by the Registrar of the Fund by 17:00 South African time on that dealing day to receive that week's price. Redemption requests must be received by the Registrar of the Fund by 17:00 South African time, on the particular dealing day on which shares are to be redeemed to receive that week's price.

Fees and charges

Permissible deductions from the Fund may include management fees, brokerage, securities transfer tax, auditor's fees, bank charges and custody fees. A schedule of fees, charges and maximum commissions is available on request from the Representative.

Total expense ratio (TER) and transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one- and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged) and other expenses like audit fees. Transaction costs (including brokerage, securities transfer tax and investor protection levies where applicable) are shown separately. Transaction costs are necessary costs in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time, including market returns, the type of fund, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and transaction costs should not be deducted again from published returns. As collective investment scheme expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and transaction costs is shown as the total investment charge (TIC).

Such contract counterparty risk is accentuated for contracts with longer maturities where events may intervene to prevent settlement, or where the Fund has concentrated its transactions with a single or small group of counterparties.

Derivatives

Borrowing, leveraging, and trading securities on margin will result in interest charges and, depending on the amount of trading activity, such charges could be substantial. The low margin deposits normally required in futures and forward trading utilized by the Fund permit a high degree of leverage; accordingly, a relatively small price movement in a futures or forward contract may result in immediate and substantial losses to the investor. Price movements of forward contracts and other derivative contracts in which the assets of the Fund may be invested are highly volatile and are influenced by, among other things, interest rates, changing supply and demand relationships, trade, fiscal, monetary and exchange control programs and policies of governments, and national and international political and economic events and policies. Forward contracts are not traded on exchanges and are not standardised; rather, banks and dealers act as principals in these markets, negotiating each transaction on an individual basis. Operating expense cap

The Investment Manager has agreed with the Fund that except for specified exclusions, operating expenses attributable to the Fund will be capped at a rate of 0.15% per annum during the Fund's financial year. The cap will be automatically extended for further successive one-year periods unless the Investment Manager notifies the Fund that the cap will not continue at least three months prior to the expiry of the term, as extended. The Investment Manager will meet expenses incurred in excess of such cap and will not seek reimbursement from the Fund. The operating expenses that are capped are all expenses excluding the fees of the Investment Manager, the cost of buying and selling assets and custody fees.
