### Fund description and summary of investment policy

The Fund invests in a focused portfolio of Frontier Market Equities. The Fund price is reported in US dollars, but the underlying holdings are denominated in various currencies. Returns are likely to be volatile.

#### Classification: Frontier Markets - Equity

### Fund objective and benchmark

The Fund aims to outperform Frontier Markets over the long term without taking on greater risk of loss. The Fund's benchmark is the MSCI Frontier Emerging Markets (FEM) Index. The Fund does not seek to mirror the benchmark but instead may deviate meaningfully from this performance benchmark in pursuit of superior returns. To the extent that its investments differ from those in the benchmark, the Fund faces the risk of underperforming the benchmark.

## **Frontier Market Equities**

There are numerous risks involved in investing in Frontier Market Equities. These risks may be significantly higher than in more developed markets and may include (but are not limited to) the following:

- Individual countries may impose capital controls preventing the repatriation of foreign currency
- Returns are expected to be more volatile, and the average drawdown may be higher, than in more developed markets

### How we aim to achieve the Fund's objective

We invest in equities that we believe offer superior fundamental value while taking into account risk and return. We research companies and assess their intrinsic value based on long-term fundamentals; we then invest in businesses where our assessment of intrinsic value exceeds the share price by a margin of safety. This approach allows us to identify shares that may be out of favour with the market because of poor near-term prospects, but offer good value over the long term. The Fund's holdings will deviate meaningfully from those in the index both in terms of individual holdings and sector exposure.



# Meeting the Fund objective

The Fund aims to outperform Frontier Markets over the long term without taking on greater risk of loss. The Fund may experience periods of underperformance in pursuit of this objective. Since inception, the Fund has outperformed its benchmark. The maximum drawdown and lowest annual return numbers in the "Performance in US\$ net of all fees and expenses" table show that the Fund has not experienced more downside than its benchmark in periods of negative market returns. We believe our philosophy of buying undervalued equities should generate positive absolute returns over time.

### Subscription and redemption charge

Investors may be charged 1% when subscribing for Fund shares. Investors may be charged 1% when redeeming Fund shares in the case of significant redemptions. These charges are paid into the Fund to offset the costs associated with the transactions that are borne by the Fund. Allan Gray Bermuda Limited (the "Investment Manager") may waive these charges if transactions substantially offset one another.

#### Annual management fee

The management fee consists of a base fee of 0.7% and a performance component. The fee rate is calculated weekly by comparing the Fund's total performance for the week, after the base fee is deducted, to that of the benchmark.

Fee for performance equal to the Fund's benchmark: 0.7% p.a.

For each percentage point above or below the benchmark we add or deduct 0.2%. This means that Allan Gray shares in approximately 20% of the performance relative to the benchmark. The fee can decrease to a minimum of 0%. If the fee would have been negative, the negative fee will be carried forward to reduce the next week's fee (and all subsequent weeks until the underperformance is recovered).

### Total expense ratio (TER) and transaction costs

The annual management fee charged is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one- and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately. The TER and transaction costs cannot be determined accurately because of the short life span of the class. Calculations are based on actual data where possible and best estimates where actual data is not available.

The volatility we saw in global markets throughout 2022 persisted in the first quarter of 2023. For the quarter, the Fund generated a return of 4.0% net of fees, versus the benchmark, which returned 2.4%. Over one year, the Fund is up 8.2%. This compares favourably with both the benchmark and the MSCI World Index, which are down 16.6% and 7.0% respectively.

In investing, it is not the early bird that catches the worm but the patient one. Investors need patience to wait for the market to present attractive buying opportunities and patience to wait for that value to materialise. As Benjamin Graham famously said, "In the short run, the market is a voting machine, but in the long run, it is a weighing machine."

As always, our focus remains on bottom-up, fundamental analysis: We look to buy above-average companies at below-average prices. We are not concerned with the speed at which a business's success is recognised. What is important to us is the underlying performance of that business. We actually like it when our preferred shares are unloved or become more so, as this presents us with an opportunity to buy good companies at bargain-bin prices. The last year provides an apt example.

Long-term readers of our commentary will know that we have liked select Georgian and Kazakhstani companies for some time, two of which are TBC Bank and Halyk Bank. Our affinity for these stocks materially predates Russia's invasion of Ukraine, an ongoing tragic event that we did not foresee. Indeed, we have been overweight these stocks to varying degrees since the inception of the Fund in 2017, and that was the case at the start of 2022.

When Russia invaded Ukraine on 24 February 2022, the market reaction was swift. Despite Kazakhstan and Georgia not being directly involved in the war, given their proximity to both nations, their markets sold off materially. For the quarter ending 31 March 2022, Halyk was down some 40% while TBC Bank was down 35%, both in US dollars. At the time, we wrote that we believed part of the sell-off was justified, but we also believed part of it to be indiscriminate, stating: "Fear and uncertainty are elevated, and there appears to be aggressive selling of these names with little consideration for existing valuations or how much of the potential downside is arguably already priced in."

As a result of the sell-off, at the end of the first quarter of 2022, one could buy both TBC Bank and Halyk on approximately three times historic earnings. This was for banks that were dominant in their respective markets, were well capitalised, and had good historic growth rates. In our March 2022 commentary, we noted: "It is not often you get to buy high-quality companies at bargain-bin prices, but we believe today presents such an opportunity." We materially increased our exposure to both counters at this time.

Where are we today? For the year ending 31 March 2023, TBC Bank is up 109% including dividends reinvested, while Halyk is up 28%. More importantly, the underlying performance of both banks has continued to be excellent. Something we could not have predicted at the time is that both companies would indirectly benefit from the conflict, with a large portion of regional trade being redirected through their markets. TBC Bank grew its earnings in lari by 23% in calendar year 2022, and some 41% in US dollars. Amazingly, the lari was one of the few currencies to strengthen against the US dollar in 2022. Halyk grew earnings by 28% in Kazakhstani tenge and 21% in US dollars.

Given the growth in earnings and low starting valuations, both counters continue to be attractively priced, and we continue to see significant upside from current prices. However, we have begun taking profits from our Georgian positions, given the significant reweighting and their overall weighting in the Fund.

The Fund has delivered a strong relative performance over the past year, and we continue to be extremely excited about its absolute return potential. We hold a number of counters trading at low prices with good growth prospects, and we believe patience will be healthily rewarded.

During the quarter, we increased our exposure to Vietnam.

#### Fees and charges

Permissible deductions from the Fund may include management fees, brokerage, securities transfer tax, auditor's fees, bank charges and custody fees. A schedule of fees, charges and maximum commissions is available on request from the Representative.

#### Total expense ratio (TER) and transaction costs

The TER is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one- and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged) and other expenses like audit fees. Transaction costs (including brokerage, securities transfer tax and investor protection levies where applicable) are shown separately. Transaction costs are necessary costs in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time, including market returns, the type of fund, the investment decisions of the Investment Manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and transaction costs should not be deducted again from published returns. #### Fair value pricing

The board of directors of the Fund (the "Board") may fair value the Fund's assets in accordance with the Board's fair value pricing policies if: 1) the closing market quotations or official closing prices are not readily available or do not accurately reflect the fair value of a Fund asset; or 2) the value of a Fund asset has been materially affected by events occurring before the Fund's pricing time but after the close of the exchange or market on which the asset is principally traded. The Board delegates the responsibility for fair value pricing decisions to a valuation committee of the Investment Manager.

#### Contractual risk

The Fund can use derivatives to manage its exposure to stock markets, currencies and/or interest rates and this exposes the Fund to contractual risk. Contractual risk includes the risk that a counterparty will not settle a transaction according to its terms and conditions because of a dispute over the terms of the contract (whether or not bona fide) or because of a credit or liquidity problem, causing the Fund to suffer a loss. #### Operating expense cap

The Investment Manager has agreed with the Fund that, except for specified exclusions, operating expenses attributable to the Fund will be capped at a rate of 0.15% per annum during the Fund's financial year. The cap will be automatically extended for further successive one-year periods, unless the Investment Manager notifies the Fund that the cap will not continue at least three months prior to the expiry of the term, as extended. The Investment Manager will meet expenses incurred in excess of such cap and will not seek reimbursement from the Fund. The operating expenses that are capped are all expenses excluding the fees of the Investment Manager, the cost of buying and selling assets and custody fees.
