### Fund description and summary of investment policy

The Fund invests mainly in selected shares and it uses exchange-traded derivative contracts on stock market indices to substantially reduce its net equity exposure to within a range of 0-20%. As a result, the Fund's return depends on the level of short-term interest rates (implicit in the pricing of the sold futures contracts) and the performance of the Fund's selected shares relative to the stock market index. The Fund's return is therefore unlikely to be correlated with equity market returns. In addition, a portion of the Fund is typically invested in cash and margin deposits.

### Fund objective and benchmark

The Fund aims to provide investors with long-term positive returns higher than those available in the money market sector, irrespective of stock market returns. The Fund's benchmark is the daily interest rate as supplied by FirstRand Bank Limited.

### How we aim to achieve the Fund's objective

The Fund invests in selected shares and seeks to substantially reduce stock market risk by selling exchange-traded equity index derivatives. The selected share portfolio is derived from our thorough research process, but the selection of equities in this Fund may differ from that in the other Allan Gray funds. The deviation of the Fund's selected share portfolio from the composition of the underlying benchmark indices (on which the derivative contracts are based) is restricted and closely monitored. This does not eliminate the risk of capital loss should the selected equities underperform.

### Suitable for those investors who

- Seek absolute (i.e. positive) returns regardless of stock market trends
- Require a high degree of capital stability over a 3-year time horizon
- Wish to invest in a product that offers uncorrelated returns relative to shares or bonds as a 'building block' in a diversified multi-asset class portfolio



### Meeting the Fund objective

Since inception and over the latest 10 year period, the Fund has outperformed its benchmark. Over the latest five-year period, the Fund has underperformed its benchmark, which is the daily interest rate supplied by FirstRand Bank Limited. The Fund aims to deliver long-term positive returns, irrespective of stock market returns.

### Annual management fee

The fee rate is calculated daily by comparing the Fund's total performance to that of the benchmark.

Fee for performance equal to the Fund's benchmark: 1.00% p.a. excl. VAT

The Fund is first required to recover any underperformance before a fee higher than the fee for performance equal to the benchmark can be charged. This is known as a high watermark. If the Fund's performance is above its previous high watermark, we add 0.2% to the fee for each percentage of performance above the high watermark. The fee is uncapped.

## Total expense ratio (TER) and transaction costs

The annual management fee is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

## **Allan Gray Optimal Fund**

The Fund returned 2.1% for the quarter, taking the year-to-date return to 8.0%. This compares favourably relative to the Fund's cash benchmark return of 1.1% for the quarter and 2.7% for the year thus far, as well as competing asset classes, such as fixed income. By way of example, the FTSE/JSE All Bond Index has returned -1.3% so far this year.

A notable contributor to quarterly performance was the Fund's relative positioning among the diversified mining and banking shares, as well as its underweight exposure to Naspers and Prosus. The Fund's preference for Glencore, and to a lesser degree South32, over the larger index heavyweights BHP and Anglo American, has added to returns. Glencore is the largest seaborne producer of thermal coal. The commodity has received a stay of execution this year, following Russia's invasion of Ukraine and the ensuing energy crisis in Europe. Mothballed coal power stations are being recommissioned ahead of the European winter as widespread gas shortages push thermal coal prices to record highs. Owing to the uncertain environment and a longer-term demand outlook that remains poor, suppliers are unlikely to respond with materially higher volumes in the short to medium term, providing attractive profits for existing producers, such as Glencore.

Within the local financial sector, we have been hesitant to overpay for earnings growth prospects. The Fund benefited from its underweight exposure to

Capitec and Discovery after both companies recently posted disappointing results relative to the high expectations factored in by the market. In comparison, Absa and Nedbank, overweight positions in the Fund, could be bought at much cheaper earnings multiples and have outperformed the sector year to date.

Sasol and Sappi were detractors this quarter. The former's share price has tracked the oil price lower in the last few months as concerns mount that rapid interest rate increases by central banks will tip economies into recession with an accompanying fall in oil demand. Related to this, the strength of the US dollar, which is reaching two-decade highs, has also weighed on commodity prices. These factors must be contrasted against the complex supply-side environment, including an emboldened OPEC+ alliance, inventory drawdowns and a subdued US shale response to date. Longer term, a growing supply deficit arising from a prolonged period of underinvestment may lend support to prices. Sasol remains a key overweight in the Fund.

During the quarter, the Fund added to existing positions in select platinum miners, Sasol, Sappi and asset managers, and trimmed its holding in Pick n Pay.

### **Management Company**

Allan Gray Unit Trust Management (RF) (Pty) Ltd (the "Management Company") is registered as a management company under the Collective Investment Schemes Control Act 45 of 2002, in terms of which it operates unit trust portfolios under the Allan Gray Unit Trust Scheme, and is supervised by the Financial Sector Conduct Authority (FSCA). #### Performance

#### Fund mandate

Funds may be closed to new investments at any time in order to be managed according to their mandates. Unit trusts are traded at ruling prices and can engage in borrowing and scrip lending. The funds may borrow up to 10% of their market value to bridge insufficient liquidity.

### Unit price

Unit trust prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund, including any income accruals and less any permissible deductions from the Fund, divided by the number of units in issue. Forward pricing is used and fund valuations take place at approximately 16:00 each business day. Purchase and redemption requests must be received by the Management Company by 14:00 each business day to receive that day's price. Unit trust prices are available daily on www.allangray.co.za.

#### Fees

Permissible deductions may include management fees, brokerage, securities transfer tax, auditor's fees, bank charges and trustee fees. A schedule of fees, charges and maximum commissions is available on request from Allan Gray.

### Total expense ratio (TER) and transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one- and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged), VAT and other expenses like audit and trustee fees. Transaction costs (including brokerage, securities transfer tax, Share Transactions Totally Electronic (STRATE) and FSCA Investor Protection Levy and VAT thereon) are shown separately. Transaction costs are necessary costs in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager, and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and transaction costs should not be deducted again from published returns. As unit trust expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and transaction costs is shown as the total investment charge (TIC).
