Fund description

The Fund invests in a focused portfolio of companies with significant business interests in Africa, regardless of the location of the stock exchange listing. The Fund price is reported in US dollars but the underlying holdings are denominated in various currencies. Returns are likely to be volatile.

Fund objective and benchmark

The Fund aims to outperform African equity markets over the long term without taking on greater risk of loss. The Fund's benchmark is the MSCI Emerging and Frontier Markets (EFM) Africa Index (total returns).

How we aim to achieve the Fund's objective

We invest in shares that we believe offer superior fundamental value while taking into account risk and return. We research companies and assess their intrinsic value based on long-term fundamentals; we then invest in businesses where our assessment of intrinsic value exceeds the share price by a margin of safety. This approach allows us to identify shares that may be out of favour with the market because of poor near-term prospects, but offer good value over the long-term. The Fund's holdings will deviate meaningfully from those in the index both in terms of individual holdings and sector exposure.

Suitable for those investors who

- Seek exposure to African equities
- Are comfortable with stock market and currency fluctuations
- Are prepared to take the risk of capital loss
- Typically have an investment horizon of more than five years

The Fund is not available to South African residents.

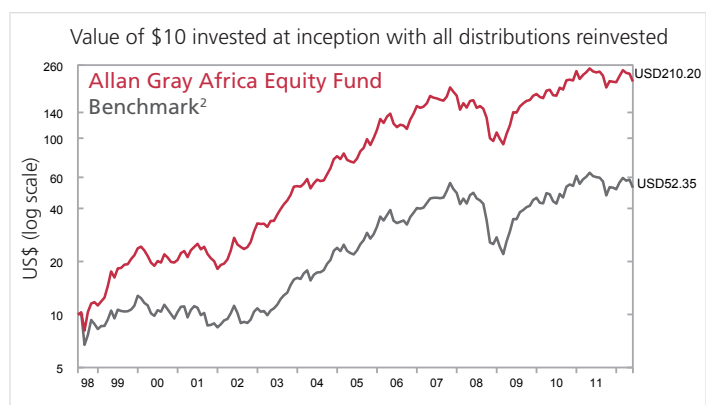
Annual management fee

The annual management fee ranges from 0.5% to 2.5% depending on the relative return of the Fund to the benchmark, before fees. The fee is calculated on a base of 1.5% plus one twenty-fifth of the cumulative three-year relative performance, subject to a floor of 0.5% and cap of 2.5%. For example if the cumulative three year performance of the fund is 20% and that of the benchmark is 15%, the fee rate is: $1.5\% + (20\% - 15\%) / 25 = 1.7\%$.

Fund manager commentary as at 31 May 2012

The Readers of the factsheet will notice we have changed both the Fund's benchmark and the reporting currency.

The Fund's benchmark has changed from the FTSE/JSE All Share Index to the MSCI EFM Africa Index. Fund investors will notice that the Fund's holdings in equities listed on exchanges other than the JSE have steadily increased over the past 18 months. These changes are in line with the Fund's mandate. The driving force behind the changes is the superior fundamental value we are finding in shares listed outside of South Africa. The exclusively South African benchmark was no longer appropriate and we decided that the MSCI benchmark better reflects the mandate of the Fund. The MSCI EFM Africa benchmark is an investable, market capitalisation weighted index. The new benchmark is heavily weighted towards South Africa as the JSE is by far the largest exchange on the African continent. This will likely change over time as the capital markets in the rest of Africa develop.

We have changed the reporting currency from South African rand to US dollars. This is consistent with the new US dollar-denominated benchmark and the fact that the Fund is only marketed to non-South African investors. The US dollar price makes more sense for, and easier comparisons of, Fund returns in a global context. The way we manage the Fund has not changed and we do not hedge any of the local currency exposure into US dollars. Rather the prices of the various assets are just converted from local currency to US dollars at the prevailing spot exchange rate.

Share price

Share prices are calculated on a net asset value basis, which is calculated by dividing the value of the net assets of the Fund attributable to the shares by the number of shares in issue. The weekly price of the Fund is normally calculated each Friday based on the prices of the underlying investments prevailing at 5:30pm Bermuda time on the previous business day. Purchase requests must be received by the Registrar of the Fund (being Citi Hedge Fund Services Limited) by 5:00pm Bermuda time on that dealing day to receive that week's price. Redemption requests must be received by the Registrar of the Fund by 12 noon Bermuda time on that dealing day to receive that week's price.

Fees

A schedule of fees, charges and maximum commissions is available on request from Allan Gray International Proprietary Limited or the Registrar. Commission and incentives may be paid and if so, would be included in the overall costs.
