Fund description

The Fund invests in a focused portfolio of companies with significant business interests in Africa, regardless of the location of the stock exchange listing. The Fund price is reported in US dollars but the underlying holdings are denominated in various currencies. Returns are likely to be volatile.

Fund objective and benchmark

The Fund aims to outperform African equity markets over the long term without taking on greater risk of loss. The Fund's benchmark is the MSCI Emerging and Frontier Markets (EFM) Africa Index (total returns).

How we aim to achieve the Fund's objective

We invest in shares that we believe offer superior fundamental value while taking into account risk and return. We research companies and assess their intrinsic value based on long-term fundamentals; we then invest in businesses where our assessment of intrinsic value exceeds the share price by a margin of safety. This approach allows us to identify shares that may be out of favour with the market because of poor near-term prospects, but offer good value over the long-term. The Fund's holdings will deviate meaningfully from those in the index both in terms of individual holdings and sector exposure.

Suitable for those investors who

- Seek exposure to African equities
- Are comfortable with stock market and currency fluctuations
- Are prepared to take the risk of capital loss
- Typically have an investment horizon of more than five years

The Fund is not available to South African residents.


Annual management fee

The annual management fee ranges from 0.5% to 2.5% depending on the relative return of the Fund to the benchmark, before fees. The fee is calculated on a base of 1.5% plus one twenty-fifth of the cumulative three-year relative performance, subject to a floor of 0.5% and cap of 2.5%. For example if the cumulative three year performance of the fund is 20% and that of the benchmark is 15%, the fee rate is: $1.5\% + (20\% - 15\%) / 25 = 1.7\%$.

Fund manager quarterly commentary as at 31 December 2012

Sasol, one of the largest holdings in the Fund, was a substantial negative contributor to the Fund's performance over the past year, declining 10% over the period compared to the benchmark's 17% price appreciation.

Sasol produces fuel and petrochemicals from coal and gas. The benefit of the technology it uses is that the reserve lives of coal and gas reservoirs tend to be far longer than those of conventional oil fields. This should allow Sasol to maintain production without the need for constant exploration expenditure.

Unfortunately Sasol has struggled to control costs and despite its 'industrial' process, the maintenance capital expenditure has exceeded depreciation by a wide margin. The company has also wasted capital on some poor investments and coal to liquids feasibility studies, which are clearly flawed in the modern world. That said, investors are well aware of these issues and have sold down the share as a result.

At current product prices Sasol should earn about R45.00 per share. These earnings are overstated by R7.00 because of the low depreciation charge. We think an oil price of US\$110/bbl is above normal, but we also think the rand should weaken from its current level. These two factors offset each other to some extent, resulting in our normal earnings estimate of R34.00 per share. Sasol, on 10 times our estimate of normal earnings, compares very favourably with the benchmark, which trades on 15 times what we think are high earnings.
