

Our Thinking

A lot can change in six months.

In early November, Pfizer fired the starting gun on global vaccine rollouts. Since then, 1.9 billion Covid vaccine doses have been given, and more than half of people in the US and UK have had at least one jab.

Markets have also seen their share of changes. Six months ago, the financial press seldom wrote about Gamestop and had scarcely heard of Roaring Kitty, the social media star who likes the stock, is not a cat, and has since testified before Congress. Bitcoin had yet to rocket again, and a rocket company CEO had neither tanked Bitcoin with a tweet nor hosted Saturday Night Live to flog a joke coin with a Shiba Inu mascot. Sports stars were just starting to act as mascots for SPACs, ARKK was a misspelling of a boat rather than a famous ticker symbol, and Goldman Sachs' index of moneylosing tech companies was more a curiosity than an important barometer of investor sentiment.

More serious things have also changed in markets since "vaccine Monday" on November 9. Gold prices fell, then recovered. The dollar dropped significantly, then rose, then dropped again. US Treasury yields have doubled from a subterranean 0.8% to the merely earthy level of 1.6%, and global equities are up another 20%, a happy figure that obscures plenty of intramural upheaval. The titans of the Nasdaq have lagged value stocks outside the US by 15%, and both banks and energy companies have bested tech shares by over 40%.

Yet some things haven't changed—notably, the concentration of world stockmarkets in the "defensive growth" shares that fared so well during lockdowns.


We highlighted this in November using the graphic at right. The vertical axis shows a company's cyclicality, and the horizontal axis shows the valuation of the stock—"value" cyclicals in the top left quadrant, "growth" defensives in the bottom right, and so on. We pointed out that over 40% of the World Index was concentrated in growth defensives. As the top chart here shows, that lopsided allocation hasn't changed.

This isn't always the case. In many past periods, the market was more balanced across different types of shares. At the eve of the global financial crisis (second chart), the tilt was the other way, towards value. The past period that looks most like today is 1999 (third chart), when expensive tech stocks dominated the index. For investors in the index, that didn't end well.

Today, some of those defensive growth stocks, like Amazon, are terrific businesses whose valuations look more reasonable after their recent underperformance. But many more—like the nearly 70 stocks in the S&P 500 that trade for more than 10 times *sales*—are priced like the next Amazon, but won't be. With this concentration, investors seem to be betting the farm that the trends of the last decade will persist. At a time when so much about markets is in upheaval, we prefer to take a more open-minded view of the

future. Accordingly, the Orbis Global Equity Strategy is well diversified, with each quadrant well represented among the top holdings. And across all four quadrants, we believe the shares we've found are more attractive than those in the index. In aggregate, the companies in the Strategy have grown revenues more quickly than the average global stock, but our shares trade at a discount on a wide range of valuation metrics. At a time when passive portfolios look lopsided, we are glad to be active investors.



Fund Objective and Benchmark

The Fund seeks higher returns than the average of the equity stock markets of the world's emerging market countries, without greater risk of loss. The MSCI Emerging Markets Index, including income, net of withholding taxes, is the Fund's benchmark (the "MSCI Emerging Markets Index").

How We Aim to Achieve the Fund's Objective/Adherence to Objective

The Fund is actively managed and is designed to be exposed to all of the risks and rewards of selected Emerging Market equities. The Fund expects to be not less than 90% invested in Emerging Market equity and equity-linked investments. The Fund identifies Emerging Market equity and equity-linked investments as those investments that are issued by a corporate body or other entity domiciled or primarily located in a country represented in the MSCI Emerging Markets Index or the MSCI Frontier Markets Index (together, "Emerging Markets"), traded or listed on an exchange in an Emerging Market or issued by a corporate body or other entity whose business is significantly linked to Emerging Markets. These equities are selected using extensive proprietary investment research. Orbis devotes a substantial proportion of its business efforts to detailed "bottom up" investment research conducted with a long-term perspective, believing that such research makes superior longterm performance attainable. The lower the price of a share as compared to its assessed intrinsic value, the more attractive Orbis considers the equity's fundamental value. The Investment Manager believes that over the long term, equity investing based on this approach offers superior returns and reduces the risk of loss. The Fund may, to the extent permitted by its investment restrictions, also periodically hold cash and cash equivalents when the Investment Manager considers this to be consistent with the Fund's investment objective.

Exchange rate fluctuations significantly influence global investment returns. For this reason, part of Orbis' research effort is devoted to forecasting currency trends. Taking into account these expected trends, the Investment Manager actively reviews the Fund's currency exposure, focusing, in particular, on managing the Fund's exposure to those currencies considered less likely to hold their long-term value.

The Fund does not seek to mirror the MSCI Emerging Markets Index and may deviate meaningfully from it in pursuit of superior long-term capital appreciation.

The net returns of the Shared Investor RRF Class (A) from its inception on 14 May 2020, stitched with the net returns of the Investor Share Class from the Fund's inception to 14 May 2020, have underperformed the stitched Performance Fee Benchmarks of the respective classes. The Fund will experience periods of underperformance in pursuit of its long-term objective.

Management Fee

As is described in more detail in the Fund's Prospectus, the Fund's various share classes bear different management fees. The fees are designed to align the Manager's and Investment Manager's interests with those of investors in the Fund.

For an initial period of time, the Shared Investor RRF Class (A) is charging the fee of the Investor Share Class, reduced by 0.3% per annum. Numerous investors have switched to the Shared Investor RRF Class (A) from the Investor Share Class. This temporary measure will ensure that the fees paid by investors account for underperformance experienced by the Investor Share Class before the inception date of the Shared Investor RRF Class (A). The fee of the Investor Share Class that is currently being charged to the Shared Investor RRF Class (A) is calculated as follows:

The fee rate is calculated weekly by comparing the Class' performance over three years against the MSCI Emerging Markets Index. For each percentage point of three year performance above or below that performance, 0.04 percentage points are added to or deducted from 1.5%, subject to the following limits:

Maximum fee: 2.5% per annumMinimum fee: 0.5% per annum

Certain capitalised terms are defined in the Glossary section of the Orbis Funds' respective Prospectuses, copies of which are available upon request from Allan Gray Unit Trust Management (RF) Proprietary Limited, a Member of the Association for Savings & Investments SA. The country and currency classification for securities follows that of third-party providers for comparability purposes. Emerging Markets follows MSCI classification when available and includes Frontier Markets. Emerging Markets currency exposure is based on currency denomination. Based on a number of factors including the location of the underlying business, Orbis may consider a security's classification to be different and manage the Funds' exposures accordingly. Totals presented in this Report may not sum due to rounding.

Risk measures are ex-post and calculated on a monthly return series. Months to recovery measures the number of months from the preceding peak in performance to recovery of that level of performance.

12 month portfolio turnover for the Orbis Equity and Multi-Asset Class Funds is calculated as the lesser of total security purchases or sales in the Fund over the period, divided by the average net asset value (NAV) of the Fund. Cash and cash equivalents are not included.

12 month name turnover for the Orbis Equity and Multi-Asset Class Funds is calculated as the number of positions held by the Fund at the start of the period but no longer held at the end of the period, divided by the total number of positions held by the Fund at the start of the period. Active share is a measure of the extent to which the holdings of the Orbis Equity and Multi-Asset Class Funds differ from their respective benchmark's holdings. It is calculated by summing the absolute value of the differences of the weight of each individual security in the specific Orbis Fund, versus the weight of each holding in the respective benchmark index, and dividing by two. For the Multi-Asset Class Funds, three calculations of active share are disclosed. The Portfolio active share incorporates the equity, fixed income, commodity-linked and other securities (as applicable) held by the Orbis Fund and compares those to the holdings of the composite benchmark. The Equity and Fixed Income active shares are calculated as if the equity and fixed income portions of the Orbis Funds are independent funds; each of those two sets of holdings is separately compared to the fully-weighted holdings in the appropriate component of the composite benchmark. Although the Multi-Asset Class Funds hedge stock and bond market exposure, the active share calculations are "gross" and not adjusted to reflect the hedging in place at any point in time.
