

Orbis Emerging Markets Equity

2022 has been challenging for emerging markets (EMs), with the MSCI EM Index down over 25% so far this year. Orbis EM Equity has fared slightly better than its benchmark, though we are not celebrating given the strategy's negative absolute returns. Despite the volatility, we remain confident that the portfolio's holdings will deliver superior long-term returns, with less risk of loss than the wider emerging market universe, while navigating potentially challenging economic conditions.

As bottom-up investors, we do not invest in stockmarkets, but rather in a concentrated portfolio of individual businesses. However, it's noticeable that the portfolio's underweight stance towards Indian shares has hurt relative returns this year. India has been one of the strongest-performing EMs in recent years, and like other investors, we can see the appeal. The country offers a diversified market comprised largely of sensibly-run owner-managed businesses, who understand the value of expensive and scarce capital. And compared to many EM countries, investors have to worry less about the rule of law, unreliable regulations, or unstable institutions.

Unfortunately, these positives are well-appreciated, and in recent years, the local market's strong returns have been driven largely by rising valuations. While India has long traded at a premium, those rising prices have widened the gap between the valuations of India versus other EMs. The Indian market now trades at a cyclically-adjusted price-earnings ratio of 26 times, compared to just 10 for the wider EM index. That makes it not just the most expensive EM, but the most expensive country anywhere in the world.

Accordingly, we have found few undervalued companies in India, and Orbis EM Equity continues to have limited exposure to Indian shares.

And while we appreciate India's attractions to investors, we see some things potentially heading the wrong way, such as a sharp decline in press freedom and the emergence of crony capitalism. We are also concerned about the country's ability to productively absorb new investment capital—critical for economic growth in the future. As long-term business owners, this is something we keep a close eye on.

In our view, overpaying for shares in any business (no matter how good) increases the risk of a permanent loss of capital. For example, a passive investor in the Indian index currently has almost one-third of their capital invested in shares trading at above 40 times next year's earnings. These expensive shares are largely in the domestic consumer goods and services sectors. Market prices have also pushed one of India's top businessmen to be the world's second-richest person, based on a domestic empire in capital-intensive old economy businesses and government contracts—a clear outlier. Not only have the richly-priced shares become even more expensive in recent years, but many of the cheapest-priced shares have also got less cheap.

Unsurprisingly, India has not been a fertile hunting ground for bottom-up stock ideas. But we do not dismiss the market entirely. Our disciplined research process has uncovered a handful of companies in India which we believe trade at attractive discounts to their long-term intrinsic value.

One such example is **ITC**, the Indian tobacco and consumer goods giant and a positive contributor to Orbis EM Equity's relative performance over the period we held it. The company has an effective monopoly over the Indian cigarette market as it captures around 95% of the industry's profits. This has been created by decades of brand building and distribution reach, making it near impossible for new and existing players to compete. Yet it only captures a small proportion of India's total tobacco consumption, due to a convoluted tax regime which protects the unregulated market and poses a more serious health hazard to the local population than regulated cigarettes. Since the mid-2000s, the company has invested cash flows from its cigarette business to diversify into its fast-moving consumer goods business, which is starting to show signs of promise. We established a position in ITC in late 2020 in the belief that its shares were trading at a discount to our assessment of intrinsic value. At the time, the tobacco sector was deeply out of favour amid tobacco-related environmental, social, and governance (ESG) issues and concerns globally. We subsequently exited the position in ITC as we were mindful of the portfolio's overall exposure to tobacco. This was predominately through the large position in British American Tobacco—which also has a stake in ITC—and which we think remains cheaper on a relative basis.

More recently, we re-established a position in **Housing Development Finance Corporation (HDFC)**, which we have owned previously. HDFC is India's leading private financial services conglomerate. Its core business is home mortgages, and it also has a stellar track record of capturing opportunities from the financial formalisation of the Indian economy. That success is reflected in its sizeable stakes in India's second-largest bank, asset management, and life insurance companies. Shares in HDFC have underperformed the broader Indian market over the last year by around 10% due to scepticism about its recently announced merger with HDFC Bank, its key associate. Post-merger, today's HDFC shareholders will own about 40% of the bank. We support the merger, as it benefits both sides of the business. The combined entity will be able to unleash the bank's entire branch distribution network to sell mortgages, while integration with the mortgage business will provide the bank with a critical low-risk, long-tenor loan product into which it can deploy its sizeable and growing deposits. While any merger of this scale comes with the usual issues of integration and culture, we are confident that management has carefully thought about these issues. In terms of scale, HDFC is a very lean organisation—less than one-tenth the headcount of HDFC Bank. Despite the strategic sense of the merger, concerns over the merger have pushed HDFC's valuation down to 18 times next year's earnings—a rare discount to the market for what has historically been a superior business.

In areas where we don't own Indian shares, it is not because we've dismissed them outright. Consider the automotive industry in India and Indonesia. Both markets enjoy long-term growth tailwinds from rising ownership levels with improving disposable incomes amongst the middle class. But car and motorbike sales are currently depressed, operating below their prior peaks. The supply side is reasonably concentrated with similar competitive dynamics, letting manufacturers generate very healthy margins across the cycle. Here, we are confronted with two choices—either we could own shares in **Astra International**, the leader in Indonesia's automotive sector, accounting for more than 50% of the industry's profits across manufacturing, dealerships and financing, or we could own a portfolio of Indian automakers, operating in a market which is triple the size of Indonesia. Importantly, both options have similar long-term returns on equity. Adjusting for its stake in a mining and heavy equipment business, Astra has a market capitalisation of less than \$15bn and trades at around 10 times earnings. By contrast, a portfolio of Indian automakers has a combined market capitalisation of around \$70bn and trades at roughly 30 times. In our view, favouring Astra is an easy decision.

Despite a sobering backdrop of disappointing performance experienced by EM investors, we remain excited about the future return potential of the portfolio's holdings. In aggregate, the average share in Orbis EM Equity trades at around 10 times next year's earnings, with a 3% dividend yield, whilst it has generated a very healthy return on equity of close to 20%. We think this is an attractive setup to deliver superior risk-adjusted returns for our clients over the long term.



How We Aim to Achieve the Fund's Objective/Adherence to Objective

The Fund is actively managed and is designed to be exposed to all of the risks and rewards of selected Emerging Market equities. The Fund expects to be not less than 90% invested in Emerging Market equity and equity-linked investments. The Fund identifies Emerging Market equity and equity-linked investments as those investments that are issued by a corporate body or other entity domiciled or primarily located in a country represented in the MSCI Emerging Markets Index or the MSCI Frontier Markets Index (together, "Emerging Markets"), traded or listed on an exchange in an Emerging Market or issued by a corporate body or other entity whose business is significantly linked to Emerging Markets. These equities are selected using extensive proprietary investment research. Orbis devotes a substantial proportion of its business efforts to detailed "bottom up" investment research conducted with a long-term perspective, believing that such research makes superior longterm performance attainable. The lower the price of a share as compared to its assessed intrinsic value, the more attractive Orbis considers the equity's fundamental value. The Investment Manager believes that over the long term, equity investing based on this approach offers superior returns and reduces the risk of loss. The Fund may, to the extent permitted by its investment restrictions, also periodically hold cash and cash equivalents when Orbis believes this to be consistent with the Fund's investment objective.

Exchange rate fluctuations significantly influence global investment returns. For this reason, part of Orbis' research effort is devoted to forecasting currency trends. Taking into account these expected trends, Orbis actively reviews the Fund's currency exposure, focusing, in particular, on managing the Fund's exposure to those currencies considered less likely to hold their long-term value.

The Fund does not seek to mirror the MSCI Emerging Markets Index and may deviate meaningfully from it in pursuit of superior long-term capital appreciation.

Management Fee

As is described in more detail in the Fund's Prospectus, the Fund's various share classes bear different management fees. The fees are designed to align the Manager's and Investment Manager's interests with those of investors in the Fund.

For an initial period of time, the Shared Investor RRF Class (A) is charging the fee of the Investor Share Class, reduced by 0.3% per annum. Numerous investors have switched to the Shared Investor RRF Class (A) from the Investor Share Class. This temporary measure will ensure that the fees paid by investors account for underperformance experienced by the Investor Share Class before the inception date of the Shared Investor RRF Class (A). The fee of the Investor Share Class that is currently being charged to the Shared Investor RRF Class (A) is calculated as follows:

The fee rate is calculated weekly by comparing the Class' performance over three years against the MSCI Emerging Markets Index. For each percentage point of three year performance above or below that performance, 0.04 percentage points are added to or deducted from 1.5%, subject to the following limits:

- Maximum fee: 2.5% per annum
- Minimum fee: 0.5% per annum

This fee is then reduced by 0.3% per annum. This 0.3% per annum reduction is provided because investors in the Shared Investor RRF Class (A) are subject to an additional administrative fee, as they separately agree with Allan Gray Proprietary Limited (or one of its affiliates) from time to time.

Certain capitalised terms are defined in the Glossary section of the Orbis Funds' respective Prospectuses, copies of which are available upon request from Allan Gray Unit Trust Management (RF) Proprietary Limited, a Member of the Association for Savings & Investments SA. The country and currency classification for securities follows that of third-party providers for comparability purposes. Emerging Markets follows MSCI classification when available and includes Frontier Markets. Emerging Markets currency exposure is based on currency denomination. Based on a number of factors including the location of the underlying business, Orbis may consider a security's classification to be different and manage the Funds' exposures accordingly. Totals presented in this Report may not sum due to rounding.

Risk measures are ex-post and calculated on a monthly return series. Months to recovery measures the number of months from the preceding peak in performance to recovery of that level of performance.

12 month portfolio turnover for the Orbis Equity and Multi-Asset Class Funds is calculated as the lesser of total security purchases or sales in the Fund over the period, divided by the average net asset value (NAV) of the Fund.
