PORTFOLIO TRACK RECORD

Commentary

The continued strong performance of defensive US stocks in this year's bull market has been noteworthy, as bull markets usually see defensive stocks do poorly. But May demonstrated that being "defensive" or paying a big dividend doesn't immunise against price declines, as many of these shares corrected on the back of a sharp drop in bonds. One of Global Balanced's investments, UK electric utility National Grid, dropped by over 5% in the last week of May. Aside from National Grid, our research process has steered your Fund relatively clear of well-known defensive shares, finding them expensive. Among electric utilities, we prefer less known but more attractively priced shares such as Korea Electric Power. In telecommunications, we've invested in places where local operators look cheap, but could achieve positive re-ratings as LTE and smartphone adoption continues, as Verizon and AT&T have done in the US. Accordingly, the Fund's telecommunications holdings span the globe from Vodafone in the UK, SK Telecom in Korea, and NTT and NTT DOCOMO in Japan.
