Commentary

Orbis Global Balanced was launched two years ago to meet clients' need for a fund that offered lower risk than our Equity Funds, but greater potential returns than the Optimal Strategy. To achieve its investment objective, Global Balanced can invest in securities such as stocks, preferred shares, bonds, and at times, commodity-linked instruments. Rather than adhere to fixed asset allocation guidelines, we retain the flexibility to place capital in the best ideas our bottom-up research uncovers. Of course, this approach relies on the performance of our individual security decisions, which disappointed this year. As painful as short-term underperformance can be, we believe it can provide an attractive opportunity to add to existing investments at lower prices. Over the past quarter, for example, we have added to the Fund's position in Mitie Group, a leading UK provider of outsourcing services, which boasts an impressive track record of growing earnings and dividends by more than 10% per annum over the past decade. In Mitie and other high-conviction holdings, we see reason for optimism about your Fund's long-term prospects.
