Commentary

For much of the past three years, your Fund has had little exposure to Basic Materials shares, which has helped its relative performance as the sector has lagged the FTSE World Index over that period. These stocks are arguably looking contrarian today, yet upon closer examination we continue to find that valuations are not cheap relative to our assessment of sustainable earnings. By contrast, we have found a handful of attractive ideas in the Oil & Gas sector. One relatively new example is Apache, an exploration and production company that focuses on finding and developing undervalued assets. It is currently suffering from depressed profitability due to recent investments in assets where production has not yet ramped up, and is highly contrarian due to its exposure to Egypt. These concerns are well known by the market and, in our view, already reflected in the stock's extremely low valuation. We believe that Apache's profitability should revert to historical levels over time, and are prepared to be patient for our thesis to play out.

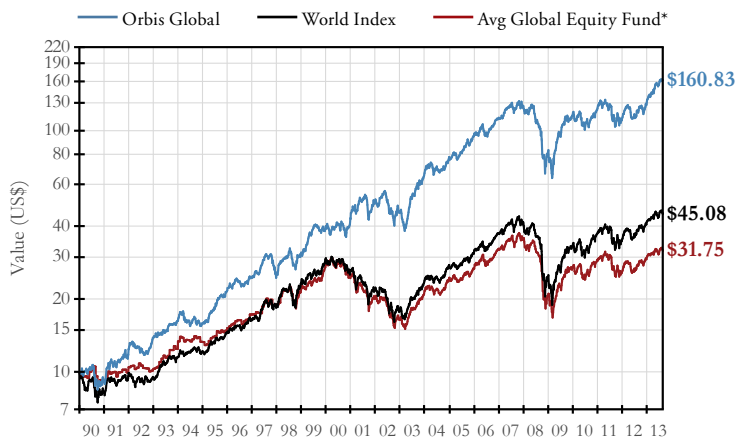

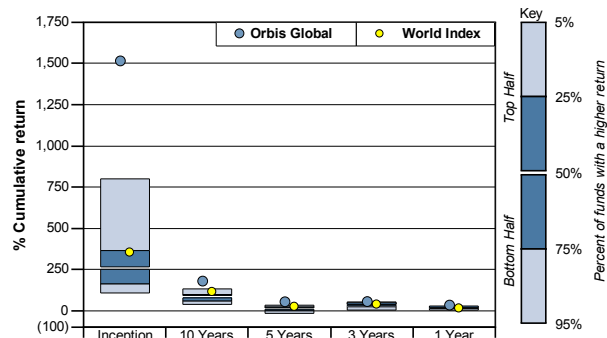
