Commentary

With the Federal Reserve winding down its asset purchases and the European Central Bank and the Bank of Japan increasing them, this year has seen plenty of moves in foreign exchange rates. These shifts can have a large impact on your returns, so we actively manage your Fund's currency exposures. As we do for companies, we try to assess the fundamental drivers of a currency's fair value, aiming to keep your Fund invested in currencies that look to be good stores of long-term purchasing power. Year-to-date, your Fund has benefitted from being overweight the Korean won, which has appreciated versus the mix of currencies in the benchmark, and underweight the euro, which has weakened versus the benchmark. Our decision to increase your Fund's exposure to the US dollar above its weighting in US equities has also added value, though exposure to the Russian rouble has detracted from performance. Though overall performance has been disappointing so far this year, our currency decisions have made a positive contribution to your Fund's return.

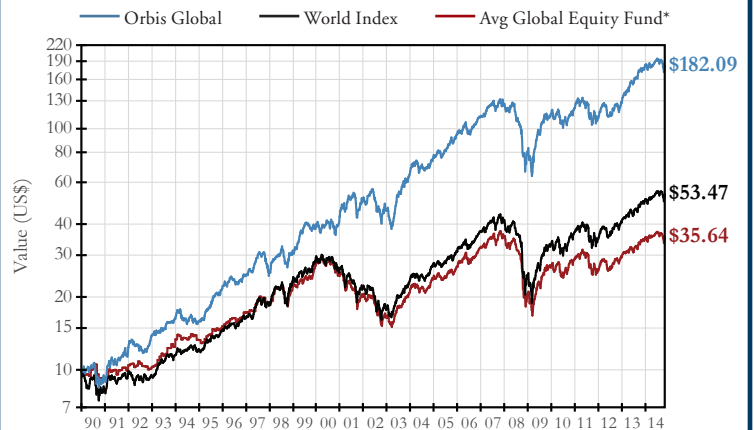

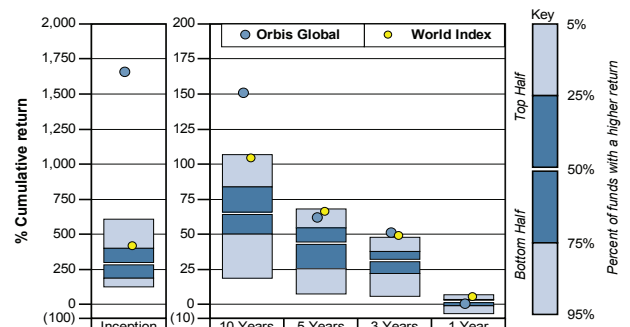
