### PORTFOLIO

#### Commentary

There are about 100 equity, fixed income and commodity-related positions in your Fund's portfolio, many of them at weights less than 1%. In this respect, the composition of Global Balanced's equity component is similar to that of our Global Equity Strategy, which has a longer history. At this time in 1990, Orbis Global held 22 positions, with the smallest holding at 3% of the Fund's net assets. Today there are 125 positions in Orbis Global and holdings >1% represent 63% of the Fund. Why the increase in smaller positions over time? The answer is that we are able to gain conviction in a larger number of opportunities. In the late 1990s, we had a single team of about seven analysts researching around 60 stocks for clients. We now have five company research teams with an average of nine people each, and each researches about as many companies as the original team did in the past. So rather than increasing the number of ideas per analyst, we have a greater number of analysts each researching the same number of companies as before—and hopefully to an even greater level of depth.

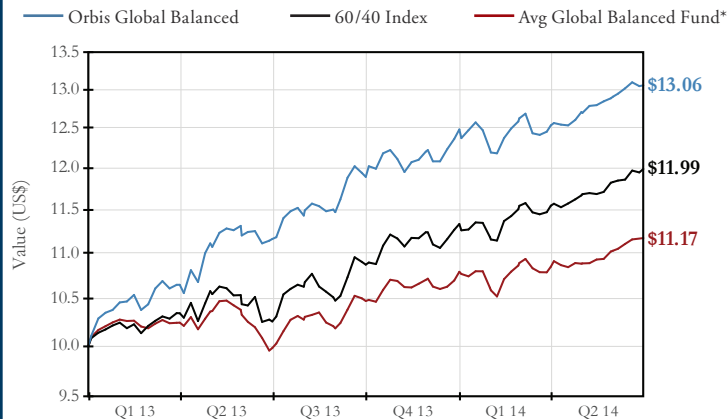

## Fund Information

The Benchmark is a composite index consisting of the MSCI World Index with net dividends reinvested (60%) and the JP Morgan Global Government Bond Index (40%).
