The Fund seeks to balance appreciation of capital, income generation and risk of loss with a diversified global portfolio of equity, fixed income and commodity-linked instruments. It aims to earn higher long-term returns than its benchmark, which is comprised of 60% MSCI World Index with net dividends reinvested and 40% JP Morgan Global Government Bond Index ("60/40 Index"), each in US dollars.

PORTFOLIO

Commentary

Following the first confirmed cases of Ebola in the US, investors have become wary of travel-related shares. A good example is Carnival plc, the world's largest operator of cruise lines and a top ten holding in your Fund. We believe the company should benefit from a cyclical recovery in the cruise industry while also delivering "self-help" through more efficient operations and improved capital allocation. But despite encouraging fundamental results and lower oil prices, Carnival shares fell by roughly 15% in early October amid widespread news coverage of Ebola and fears of a case on one of its ships. Looking at the 2003 SARS outbreak and the H1N1 flu in 2009, the point of maximum news coverage marked the beginning of the end for the pandemic. While we cannot be certain, we believe the Ebola outbreak is now near this "maximum point". The disease is also harder to transmit than SARS and H1N1, and Carnival's lines do not port anywhere in West Africa. Accordingly, we continue to have conviction in our investment thesis, and we are confident that our patience will be rewarded over the long term.

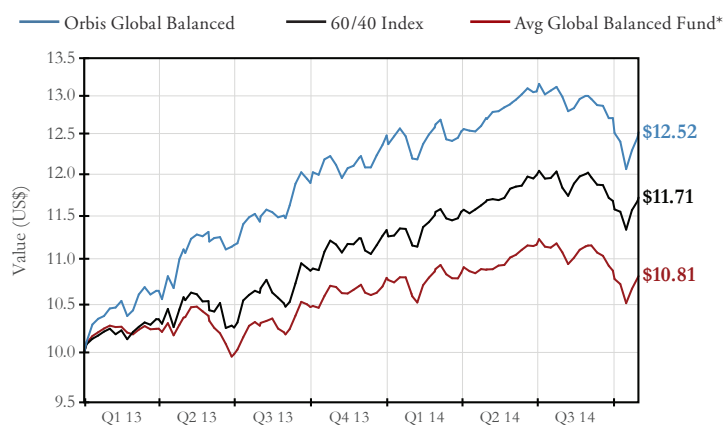
