Commentary

We are pleased to report that the operations of the companies in your Fund are recovering quickly from the effects of the March earthquake. In the immediate aftermath we felt strongly that the market's initial reaction exceeded any fall in the intrinsic value of the underlying companies and we expected a recovery that would be measured in months rather than years. However, even we have been pleasantly surprised by how rapid the rebound has been. This is particularly true across the consumer services companies, to which your Fund has a significant overweight exposure versus the benchmark. Sales at retailers have returned to positive year-on-year growth, passenger volumes at rail companies have almost fully recovered and TV advertising has bounced back. While we acknowledge that Japan's long-term macroeconomic outlook is deeply challenging, we have confidence in the stocks the Fund holds and believe that we can continue to find attractive investment opportunities.

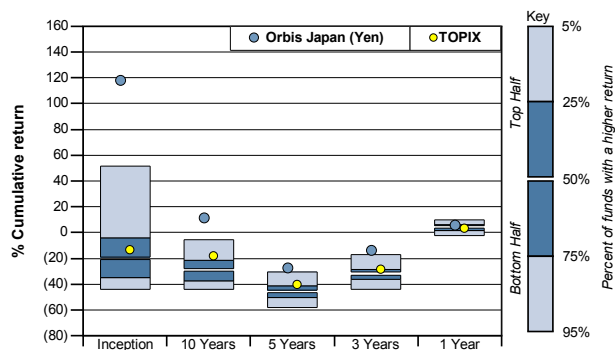

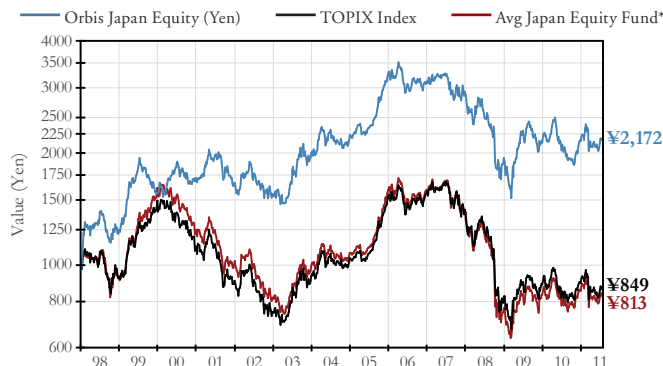

Ranking within Japan equity fund peer group**

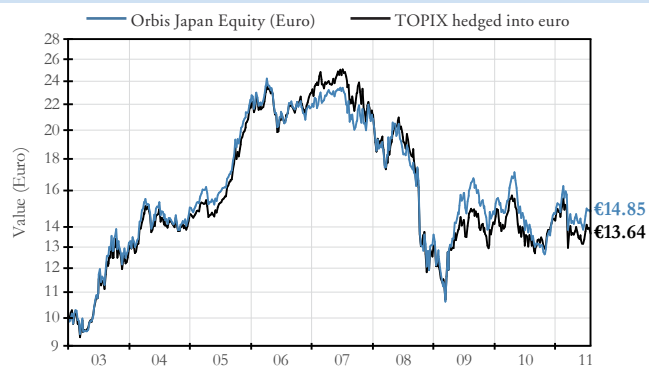
